CY107091 of Mount Pocono, Monroe County, was levied a civil penalty of \$500; costs of investigation of \$36.58; received a reprimand on its disciplinary record with the Board, and it must cease and desist the possession and use of metal rasp tools in the practice of cosmetology, because it operated as a cosmetology salon in a grossly incompetent and unethical manner through the possession and use of metal rasp tools. ### **Northampton County**

Fashion Nails, license no. CY197319 of Bethlehem, Northampton County, was levied a civil penalty of \$2,000; costs of investigation of \$18.29; received a reprimand on its disciplinary record with the Board, and must cease and desist in the possession of MMA (Methyl Methacrylate) substance, because it operated as a nail technology salon in a grossly incompetent and unethical manner through the possession of MMA substance. La Nails And Spa, license no. CY196927 of Bethlehem, Northampton County, was levied a civil penalty of \$1,500; costs of investigation of \$34.39; a reprimand was placed on its disciplinary record with the Board, and it must cease and desist the possession and use of MMA and metal rasp tools in the practice of nail technology, because it failed to post a sign as required by the Clean Indoor Air Act, operated as a nail technology salon in a grossly incompetent and unethical manner by possessing MMA, and by possessing a metal rasp tool. (4/27/20)

### **Philadelphia County**

Theresa K Kuruc, license no. CO201286L of Philadelphia, Philadelphia County was levied a civil penalty of \$1,500; and a reprimand was placed on her permanent disciplinary record with the Board, because she violated a Board regulation by practicing cosmetology without a current and active license. (4/27/20)

Bellisimo Hair Fashion, license no. CB091778L of Philadelphia, Philadelphia County, was levied a civil penalty of \$1,250; received a public reprimand, and must cease and desist employing unlicensed individuals, because it operated as a nail technology salon in a grossly incompetent, unethical manner by employing an unlicensed individual, aided and abetted the unlicensed practice of cosmetology, operated without a manager. (1/6/20)

Sally Le, license no. CQ111557 of Philadelphia, Philadelphia County, was levied a civil penalty of \$500; and received a reprimand on her disciplinary record with the Board, because she practiced esthetics without a current and active license (3/2/20)

Harold Joseph Harper, D.M.D., license no. CO295072, of Philadelphia, Philadelphia County, had his license to practice as a Cosmetologist temporarily suspended, pending a hearing, on the grounds that his continued practice within the Commonwealth may be an immediate and clear danger to the public health and safety. (06/16/20)

### **Wayne County**

Rt 6 Nail Salon, license no. CY197469 of Honesdale, Wayne County, was levied a civil penalty of \$3,350 and a cost of investigation of \$79.35, a reprimand was placed on their disciplinary record with the Board, and must cease and desist the possession and use of metal rasp tools in the practice of nail technology, because they violated the law by employing two unlicensed individuals, having operated as a nail technology salon in a grossly incompetent and unethical manner by the possession of two metal rasp tools, by having a first aid kit that was missing a blood spill kit, by failing to have an employee's license displayed in a conspicuous place, by failing to maintain equipment in a sanitary condition at all times and by failing to maintain towels in a closed container. William Thomas Kane, license no. DS024694L of Levittown, Bucks County, was levied a civil penalty of \$4,800; and a reprimand was placed on his disciplinary record with the Board, because he employed a dental hygienist whose license was not current (5/15/20)

### **Butler County**

DH012736L of Butler, Butler County, was suspended for a minimum period of three years, immediately stayed in favor of probation, because she is unable to practice as a dental hygienist with reasonable skill and safety to patients by reason of illness, drunkenness, excessive use of controlled substances, chemicals or any other type of material, or as the result of any mental or physical condition. ### **Lancaster County**

Rochelle Marie Richardson, license no. DH067971 of Mount Joy, Lancaster County, was levied a civil penalty of \$1,450; and a reprimand was placed on her disciplinary record with the Board, because she knowingly engaged in the activities of a dental hygienist while her license was lapsed, expired, and not current with the Board. ### **Lehigh County**

DH011597L of Coopersburg, Lehigh County, was levied a civil penalty of \$2,000; costs of investigation of \$539.40; was indefinitely suspended retroactive to March 9, 2020.
