Respondent is subject to disciplinary action under the Revised Uniform Law on Notarial Acts, 57 Pa.C.S. §323(a)(3), in that Respondent lacks the honesty, integrity, competence, or reliability to hold the office of notary public.

Rita Jones, notary commission number 1309605, of Philadelphia, Philadelphia County, is prohibited from reapplying for appointment and commission as a notary public for four years, based on her notarization of a deed for real property where the grantor was deceased at the time of notarization. Respondent is subject to disciplinary action under the Revised Uniform Law on Notarial Acts, 57 Pa.C.S. §323(a), in that Respondent lacks the honesty, integrity, competence, or reliability to hold the office of notary public based on Respondent's failure to discharge duties required of a notary public. These duties include the failure to require personal appearance of the signer, failure to provide the Department of State's Bureau of Enforcement and Investigation investigator with certified copies of her notarial journal and failure to record information about the type of notarial act performed and/or the full address of the individuals for whom the notarial acts were performed for each entry in the journal. 12-22-2021.

Ricky Rawls, notary commission number 1276543, of Philadelphia, Philadelphia County, is prohibited from reapplying for appointment and commission as a notary public for four years, based on his notarization of a deed for real property where the grantor did not appear before him at the time of notarization. Respondent is subject to disciplinary action under the Notary Public Law, 57 P.S. § 168, in that Respondent 1) failed to know through personal appearance or satisfactory evidence that the person appearing before him was the person described in and who was executing the instrument to be notarized; 2) failed to keep and maintain custody and control of a notary register of all official acts performed; 3) failed to be familiar with the duties and responsibilities of a notary public; and 4) failed to be of sufficient ability to be a notary public. 12-28-2021.
