Stephen E. Sulzbach, D.M.D., dentist license no. DS037756, of Greenville, Mercer County, was ordered to pay a civil penalty in the amount of \$3,000.00 and the costs of investigation in the amount of \$3,340.89 because he engaged in unprofessional conduct in the practice of dentistry. (3/14/23)

## **Westmoreland County**

Nicole M Conforti, certificate no. MSG012772, of Spring City, Chester County, permanently voluntarily surrendered her massage therapist license, he chose not to contest the facts and where the Board found that he engaged in sexual harassment, sexual impropriety, sexual violation or sexual abuse, failed to use safe and functional coverage/draping practices, violated a client's boundaries with regard to exposure, privacy, or disclosure, failed to obtain written consent prior to performing breast massage, and intentionally exposed a client's genitals, gluteal cleft or the breasts of a female client except temporarily to perform therapeutic treatment of the area. MSG007084, of Waynesburg, Greene County, agreed to pay an assessment towards the costs of investigations in the amount of \$2,500; and complete ten hours of remedial education, because he violated a client's boundaries with regard to exposure, privacy or disclosure and failed to discuss with a client which massage therapy modalities and techniques would be utilized and the benefits of these modalities and techniques, the objectives, and that participation is voluntary and that consent to treatment or participation may be withdrawn at any time. MSG009346 of Philadelphia, Philadelphia County, had his license to practice as a massage therapist temporarily suspended, pending a hearing, on the grounds that his continued practice within the Commonwealth presents a clear and immediate danger to the public health and safety. MSG004174, of Hanover, York County, permanently voluntarily surrendered his license, because he engaged in sexual harassment, sexual impropriety, sexual violation or sexual abuse, failed to use safe and functional coverage/draping practices during the practice of massage therapy when the client was disrobed, violated a client's boundaries with regard to exposure, privacy, or disclosure, failed to obtain written consent prior to performing breast massage, and intentionally exposed a client's genitals, gluteal cleft or the breasts of a female client except temporarily to perform therapeutic treatment of the area. RN623344, of Pittsburgh, Allegheny County, was automatically suspended for one year and indefinitely suspended for three years, such suspensions to be served concurrently and stayed in favor of three years probation retroactive to July 21, 2021, because she is unable to practice nursing with reasonable skill and safety to patients by reason of physiological or psychological dependence upon hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. VD025815 of Lancaster, Lancaster County, were levied civil penalties of \$2,000 each; and both received a reprimand on their permanent disciplinary records with the Board, because they were convicted of insurance fraud, a crime directly related to their trade, occupation or profession and they pose a substantial risk of further convictions; while their current license is in force, he pled guilty, entered a plea of nolo contendere, or was found guilty in a court of competent jurisdiction in this or any other state of Federal jurisdiction of forgery, embezzlement, obtaining money under false pretense, extortion, conspiracy to defraud, bribery, odometer tampering or any other crime involving moral turpitude by being convicted of Insurance Fraud. BV012536, of Cochranton, Crawford County, was levied a civil penalty of \$3,000; costs of investigation of \$1,783; and must complete a remedial education course in veterinary law and ethics, because she violated the Board's regulation which requires that: "Veterinarians practice in accordance with current advancements and acceptable and prevailing standards of care in veterinary medicine, including using current proven techniques, drugs and scientific research that may affect treatment decisions. Veterinarians shall practice in accordance with advancements and acceptable and prevailing standards of veterinary medical practice in this Commonwealth related to the pharmacologic properties, indications and contraindications of drugs and biologics." (3/24/23)

## **Schuylkill County**

Allen Post Bonnell, license no. BV011333, of New Ringgold, Schuylkill County, was levied a civil penalty of \$5,000; costs of investigation of \$1,968; received a reprimand on his disciplinary record with the Board; and must complete remedial education on the topics of Veterinary Law and Ethics and Veterinary Medical Records because he violated the Board's regulation Principle 3- Unprofessional Conduct, which prohibits a veterinarian from engaging in merchandising which is defined in the regulations as the buying and selling of professional veterinary products without a veterinarian/client relationship; by violating the Board's regulation Principle 8(b) by prescribing prescription drugs to animals that were not under his care; and he violated the Board's record keeping regulations by failing to maintain required veterinary medical records.
