(who had stage 4 cancer) with “exosomes,” displayed gross incompetence, negligence or misconduct; committed immoral or unprofessional conduct; made representations that chiropractic treatment would cure cancer; made misleading, deceptive, untrue and/or fraudulent representations regarding an informed consent document which falsely represented the role of a medical doctor, and/or by indicating that treatment with exosomes would cure cancer; failed to refer R.R. to a licensed practitioner of another branch of the healing arts; made misleading, deceptive, untrue or fraudulent representations by marketing exosome products as treatments for a number of diseases and conditions; published advertisements, letterhead, signs and/or other printed material that failed to indicate his profession; committed immoral or unprofessional conduct by advertising regarding exosomes which created false or unjustified expectation of beneficial treatment for a successful result; committed unprofessional conduct by ordering excessive tests or treatment by ordering IV infusions of exosomes, a non-FDA approved treatment and/or a topical cosmetic product; and committed immoral or unprofessional conduct by using a medical doctor’s name and NPI number to order exosomes without the medical doctor’s knowledge or permission.
