AF062805, of Pittsburgh, Allegheny County, was ordered to pay a civil penalty of \$3,000.00, and pay the costs of investigations of \$66.12, because they engaged in the practice of public accounting in the Commonwealth without holding a current license. ### **Somerset County**

Dale L. Tomlinson, notary commission no. 1301484, of Windber, Somerset County, voluntarily surrendered Tomlinson's notary commission because Tomlinson failed to maintain a journal of notarial acts performed that contains all required information in chronological order. (07/24/2023).

## **York County**

Ashley S D King, notary commission number 132945, of York, York County, is prohibited from reapplying for appointment and commission as a notary public for a period of four years, based on her failure to promptly notify the Department on discovering that her journal was lost or stolen. Kathryn M. Arguelles, license No. PN264637, of West Reading, Berks County, had her license reinstated to probationary status after complying with the terms of a prior board order. (03/10/23)

MV211339, of Waymart, Wayne County, agreed to the permanent voluntary surrender of Koezeno Sr's license, because Koezeno Sr poses a substantial risk to the health and safety of Koezeno's clients or the public or a substantial risk of further criminal convictions and violated CHRIA and the Vehicle Act by receiving a conviction for a crime involving moral turpitude because Koezeno Sr was convicted of one count (1) of Murder of the Third Degree a felony of the first degree. ### **Out of State**

Dustin Crooks, PA license no. MV264690, of Midlothian, Virginia was ordered to pay a civil penalty of one thousand five hundred dollars (\$1,500.00), because Crooks Violated the act when Crooks was convicted of Theft by Deception-False Impression, a first-degree misdemeanor, a crime directly related to Crooks' occupation, trade or profession. Yamaha Motor Corp USA, PA license no. VM000484L, of Cypress, California was ordered to pay a civil penalty in the amount of forty thousand dollars (\$40,000.00) and a public reprimand shall be placed on its permanent disciplinary record with the Board because Yamaha Motor Corp USA acted as a vehicle manufacturer on a lapsed and expired license.
