CY011241 & CZ120004, of Leesport, Berks County, was levied a civil penalty of \$2,600; and received a reprimand on its permanent record with the Board, because Passion 4 Nails And Spa operated as a nail technology salon in a grossly incompetent, unethical manner through the possession of Methyl Methacrylate, metal rasp tools, and by operating without a blood spill kit and having expired eyewash. Posh Nails and Spa, license nos. CY197877 and CZ119394, of Blandon, Berks County, was levied a civil penalty of \$500; and received a reprimand on its permanent record with the Board, because it operated in a grossly incompetent and unethical manner by employing an unlicensed individual. (5/22/23)

Decire Beauty Salon, license no. CB119860, of Reading, Berks County, was levied a civil penalty of \$500; because it operated as a cosmetology salon without a current and active license. (5/22/23)

#### **Bucks County**

Vitaliia Didukh, license no. CL188223, of Feasterville-Trevose, Bucks County, was levied a civil penalty of \$500; and received a reprimand on her permanent record, because she practiced nail technology without a current and active license. (5/22/23)

CO259311, of Lansdowne, Delaware County, was levied a civil penalty of \$500; and received a reprimand on her permanent record with the Board, because Gomez practiced cosmetology without a current and active license from on or about February 1, 2020, until May 6, 2021. Sophia M. Nuckels, license number CQ116321, of Brownsville, Fayette County, had her license to practice as an esthetician suspended indefinitely, with said suspension stayed in favor of an indefinite period of probation based on her criminal convictions. (05/10/23)

The Lavender Room Salon, license no. CB124695, of Lebanon, Lebanon County, was levied a civil penalty of \$500; and received a reprimand on its permanent record with the Board, because it practiced as a cosmetology salon at a time its license was lapsed or unregistered. (5/22/23)

Joselle M Cutrufello, license nos. CO224729L, of Bethlehem, Lehigh County, was suspended for 3 years, stayed in favor of probation, levied a civil penalty of \$250; and received a reprimand on her permanent record with the Board, because Cutrufello was convicted of Theft by Unlawful Taking- Movable Property, a crime directly related to her profession, and she poses a substantial risk to the health and safety of her clients or the public, or a substantial risk of further criminal convictions, and acted in an unethical and dishonest manner by answering legal questions untruthfully on her initial application, and she obtained her cosmetology teacher license by fraud or misrepresentation by failing to truthfully answer the legal questions on her initial application. Brian D Fasick, license no. CO159420L, of Allentown, Lehigh County, was levied a civil penalty of \$500; and received a reprimand on his permanent record with the Board, because he practiced cosmetology without a current and active license. (5/22/23)

#### **Luzerne County**

Dejavu Beauty Center Inc, license no. CB123925, of Hazleton, Luzerne County, was suspended for two years, stayed in favor of probation, levied a civil penalty of \$2,000; and received a reprimand on its permanent record with the Board, because it engaged in gross incompetency or dishonest or unethical conduct, by employing an unlicensed individual in the profession of cosmetology, and aided and abetted an individual in the unlicensed practice of cosmetology. ### **Montgomery County**

Thuan Thai Phan, license no. CL021602L, of Norristown, Montgomery County, was levied a civil penalty of \$500; and received a reprimand on his permanent record with the Board, because Phan practiced nail technology without a current and active license. (5/22/23)

The Colour Bar Hair Salon, license no. CB129206, of Harleysville, Montgomery County, was suspended for failing to pay a previously imposed civil penalty. (04/18/23)

Serenity Nail Blow Dry Bar and Day Spa, license no. CB125217, of Conshohocken, Montgomery County, was suspended for failing to pay a previously imposed civil penalty. (04/18/23)

Sonya Rae Connors, license no. CM010991L, of Greensburg, Westmoreland County, was suspended for no less than two years, stayed in favor of probation, levied a civil penalty of \$500; and received a reprimand on her permanent record with the Board, because Connors was convicted of Aggravated Assault, Simple Assault, Resisting Arrest, and Aggravated Harassment by Prisoner, and due the nature of the criminal convictions, licensure would pose a substantial risk to the health and safety of her clients or the public, and/or poses a substantial risk of further convictions.
