The 2021 Municipal Primary Ballot Position Lottery for the offices listed below will be held Wednesday, March 17, 2021, in Harrisburg, Pennsylvania beginning at 9:30 A.M. It is not necessary that candidates be present. A candidate may have someone draw in the candidate's place by executing a **written proxy**. Proxies must be duly signed by the candidate and notarized as required by law. In the absence of a candidate or a duly authorized proxy, the Secretary of the Commonwealth will appoint a person to draw for the candidate. **Please note that due to COVID building capacity guidelines, it is requested that if you choose to attend, you only remain present during the time your position is being drawn.**
