This will be an exciting election year for the commonwealth and for its voters. As the state's Chief Election Official, I am proud to present the 2020 Pennsylvania Election Calendar, a comprehensive guide for voters, candidates, and election officials.

In October 2019, Governor Wolf signed into law the most significant set of voting reforms in more than 80 years. This new law features changes that will make voting easier and more accessible for millions of Pennsylvanians. Voters will have more options in how to cast their ballots, including:

- Registering to vote up to 15 days before Election Day.
- The option to request and vote a no-excuse mail-in ballot.
- Requesting to be placed on a permanent mail-in or absentee ballot list.
- Submitting a mail-in or absentee ballot until 8 p.m. on Election Day.

Further details about the new law and deadlines can be found in this guide. In addition, the Department of State has many resources available on our website, votesPA.com. Through the website, voters can request absentee or mail-in ballots through an online application, verify their voter registration, check their polling place, and much more.

The 2020 Pennsylvania Election Calendar also provides valuable information for candidates and their campaign staff to track important dates related to ballot access and campaign finance deadlines and requirements. Audits of campaign finance reports will be made upon the petition of five electors of the commonwealth or of the political division. Such petition(s) must be presented to the appropriate Court within 90 days after the last day for filing the report.

^{**}Your notarized cover page must be received in our office ten calendar days (including weekends) after the filing deadline. Postmarks will not be accepted.

JUNE 2, 2020 GENERAL PRIMARY NOVEMBER 3, 2020 . GENERAL ELECTION

DECEMBER 30, 2019 Last day for the Secretary of any political party to file in the office of the **SECRETARY OF THE COMMON-WEALTH**, a certified copy of the party rules.

JANUARY 13 Last day for a Presidential candidate to notify the SECRETARY OF THE COMMONWEALTH that he or she authorizes delegates and alternate delegates (if party rules provide for committed delegates) to pledge their support for him or her.

JANUARY 28 Last day for each county board of elections to transmit to the SECRETARY OF THE COMMONWEALTH a list of the organizations which qualify as political parties within the county pursuant to section 801(b) of the Pennsylvania Election Code, 25 P.S. § 2831(b).

JANUARY 28 Last day for the SECRETARY OF THE COMMONWEALTH to transmit to each county board of elections a list of the organizations which qualify as political parties within the State pursuant to section 801(a) of the Election Code, 25 P.S. § 2831(a).

JANUARY 28 Last day for the chairmen of

county committees (and in Philadelphia the chairmen of the city committees) of each party to send to each county board of elections a written notice setting forth all party offices to be filled in the county at the ensuing primary.

JANUARY 28 Last day for the chairmen of the State Committees of political parties to forward to the SECRETARY OF THE COMMONWEALTH and to the respective county boards of elections, a written notice setting forth the number of members of the State Committee and the number of delegates and alternate delegates to be elected at the said primary in each county or in any district or part of a district within each county.

JANUARY 28 Last day for the SECRETARY OF THE COMMONWEALTH to send to the county boards of elections a written notice designating the public offices for which candidates are to be nominated at the ensuing primary and for which nominations candidates are required to file nomination petitions in the office of the SECRETARY OF THE COMMONWEATH.

JANUARY 28 First legal day to circulate and FILE nomination petitions.

JANUARY 29 Not later than this day, the county boards of elections must prepare an election notice to be used in conjunction with the Federal Write-in Absentee Ballot (FWAB)

JANUARY 31 Last day for all candidates and all political committees and lobbyists to file annual expense reports in the office of the SECRETARY OF THE COMMONWEALTH or the county boards of elections. Such reports shall be complete as of December 31, 2019.

- **NOTE:** Postmarks are acceptable as proof of timely filing where the report is postmarked by the U.S. Postal Service no later than the day prior to the filing deadline.
- **FEBRUARY 3** Not later than this day, the county boards of elections must mail absentee ballot applications to individuals on the permanent absentee ballot list.
- **FEBRUARY 3** Not later than this day, the county boards of elections must mail mailin ballot applications to individuals on the permanent mail-in ballot list.
- **FEBRUARY 4** Not earlier than this day nor later than February 11, the county board of elections shall begin to publish in newspapers the names of all public offices for which nominations are to be made and the names of all party offices for which candidates are to be elected at the ensuing primary.
- FEBRUARY 18 Last day for any business entity which was awarded non bid contracts from the Commonwealth or its political subdivisions during 2019 to report to the SECRETARY OF THE COMMONWEALTH an itemized list of all political contributions made during 2019 by (1) any officer, director, associate, partner, limited partner, individual owner or member of their immediate family when the contribution exceeded an aggregate of one thousand dollars (\$1,000) by any Individual; or (2) any employee or members of his/her immediate family when the contribution exceeded an aggregate of one thousand dollars (\$1,000).
- **FEBRUARY 18** Last day to circulate and **FILE** nomination petitions.
- FEBRUARY 18 Last day for STATE LEVEL PUBLIC OFFICE CANDIDATES to FILE

"Statements of Financial Interests" with the State Ethics Commission, Room 309 Finance Building, P.O. Box 11470, Harrisburg, PA 17108 1470. A copy of the "Statement" must also be appended to the nomination petition. Last day for candidates for county or local level public office to file the "Statement" with the governing authority of the political subdivisions in which they are candidates. A copy of the "Statement" must also be appended to the nomination petition.

- **FEBRUARY 19** First day to circulate and **FILE** nomination papers nominating independent candidates of political bodies or candidates of minor political parties.
- **FEBRUARY 25** Last day to file **OBJECTIONS** to nomination petitions.
- **FEBRUARY 26** Day for casting of lots in the office of the **SECRETARY OF THE COM-MONWEALTH** for position of names upon the primary ballot.
- **FEBRUARY 28** Last day that may be fixed by the Court of Common Pleas or the Commonwealth Court for hearings on objections that have been filed to nomination petitions.
- **MARCH 4** Last day, if possible, for the Court of Common Pleas or the Commonwealth Court to render decisions in cases involving objections to nomination petitions.
- **MARCH 4** Last day for candidates who have filed nomination petitions for the primary election to withdraw, by 5:00 P.M.
- MARCH 9 Last day for the SECRETARY OF THE COMMONWEALTH to transmit to each county board of elections a list of all candidates who filed nomination petitions with him and who are not known to have

withdrawn or been disqualified.

MARCH 9 Not later than this day, the county boards of elections must begin to transmit ballots and balloting materials to all covered voters under the Uniformed Military and Overseas Voters Act (UMOVA) in extremely remote or isolated area, who by that date, submit a valid military-overseas ballot application.

[The preceding includes qualified electors who are Uniformed-Service voters (members of the active or reserve components of the Army, Navy, Air Force, Marine Corps or Coast Guard of the United states who are on active duty; members of the United States merchant marine, the Commissioned Corps of the Public Health Service of the Department of Health and Human Services or the Commissioned Corps of the National Oceanic and Atmospheric Administration of the United States; members on activated status of the National Guard or Pennsylvania National Guard); Spouses and dependents of uniformed service members; Overseas voters; or veterans of a uniformed service who is bedridden or hospitalized due to illness or physical disability.]

NOTE: As additional applications are received, the county board of elections must transmit ballots and balloting materials to such electors within 48 hours after the application is received by the county board of elections.

MARCH 9 First day on which county boards of elections must begin to process official applications for mail-in ballots.

NOTE: A county board of election may begin to process applications earlier if it deems it appropriate.

MARCH 9 First day on which county boards

of elections must begin to process official applications for civilian absentee ballots.

NOTE: A county board of election may begin to process applications earlier if it deems it appropriate.

MARCH 14 Not later than this day, the county boards of elections must begin transmitting ballots and balloting materials to all covered voters under UMOVA who by this date submit a valid military-overseas ballot application.

[The preceding includes qualified electors who are Uniformed-Service voters (members of the active or reserve components of the Army, Navy, Air Force, Marine Corps or Coast Guard of the United states who are on active duty; members of the United States merchant marine, the Commissioned Corps of the Public Health Service of the Department of Health and Human Services or the Commissioned Corps of the National Oceanic and Atmospheric Administration of the United States; members on activated status of the National Guard or Pennsylvania National Guard); Spouses and dependents of uniformed service members; Overseas voters; or veterans of a uniformed service who is bedridden or hospitalized due to illness or physical disability.]

NOTE: As additional applications are received, the county board of elections must transmit ballots and balloting materials to such electors within 48 hours after the application is received by the county board of elections.

MARCH 17 Last day for candidates for statewide offices and treasurers of political committees and lobbyists which have expended money for the purpose of influencing the nomination of such candidates to file campaign expense reports or statements due by the Sixth Tuesday before the primary election in the office of the **SECRETARY OF THE COMMONWEALTH.** Such reports shall be complete as of March 9.

NOTE: Postmarks are acceptable as proof of timely filing where report is postmarked by the U.S. Postal Service no later than the day prior to the filing deadline.

MAY 18 Last day to **REGISTER** before the primary election.

NOTE: To be processed for the ensuing election a voter registration application must be received as follows:

- * Voter registration applications submitted to the Pennsylvania Department of Transportation in conjunction with an application for or renewal of a motor vehicle driver's license must be received by the county voter registration commission not later than the deadline to register.
- * Voter Registration Mail Applications must be must be received by the county voter registration commission not later than the deadline to register.
- * Voter registration applications submitted to offices in Pennsylvania that provide public assistance, to the county clerk of Orphan's Court, including the Marriage License Bureau, offices in Pennsylvania that provide State-funded programs primarily engaged in providing services to persons with disabilities and armed formces recruitment centers, must be received by the county voter registration commission not later than the deadline to register.
- * All other voter registration applications must be received by the deadline to register.

- MAY 18 Last day to change party enrollment or non-partisan enrollment.
- MAY 19 As soon as possible after ballots are printed and in no event later than this day, the county boards of elections must begin to deliver or mail all mail-in ballots.

NOTE: As additional applications are received, ballots must be mailed within 48 hours after approval.

MAY 19 As soon as possible after ballots are printed and in no event later than this day, the county boards of elections must begin to deliver or mail all absentee ballots.

NOTE: As additional applications are received, ballots must be mailed within 48 hours after approval.

MAY 22 Last day for all candidates and treasurers of political committees and lobbyists which have expended money for purpose of influencing the nomination of candidates file campaign expense reports or statements due by the Second Friday before the primary in the office of the SECRETARY OF THE COMMONWEALTH and/or the county boards of elections, as the case may be. Such reports shall be complete as of May 18.

NOTE: Postmarks are acceptable as proof of timely filing where the report is postmarked by the U.S. Postal Service no later than the day prior to the filing deadline.

MAY 23 Not earlier than this day nor later than May 30, the county boards of elections shall publish in newspapers, notice of the date and hours of voting for any special elections, the names of offices to be elected and the names of the candidates at such special elections, the texts and explanations of Constitutional Amendments and other

questions to be voted upon, and the places at which such elections are to be held in the various election districts.

MAY 26 Last day before the November election on which an elector, who has suffered a physical disability which requires him/her to have assistance in voting, may personally make application to the county registration commission in all counties to have such fact entered on his/her registration card.

NOTE: If the disability is not recorded on the elector's registration card, the elector may receive assistance if the elector completes a declaration in the polling place.

MAY 26 Last day for any person to file a petition with the county registration commission appealing against rejection of a voter registration application.

MAY 26 Last day before the primary election on which official applications for mail-in ballots may be received by the county boards of elections, due at 5:00 P.M.

MAY 26 Last day before the primary election on which official applications for civilian absentee ballots from certain persons listed as follows may be received by the county boards of elections, due at 5:00 P.M.

(The preceding includes qualified registered electors who will be absent from the Commonwealth or municipality of residence by reason of occupation, business or duties; persons unable to go to the polls because of illness or physical disability; persons observing a religious holiday; county employees with duties on election day relating to the conduct of the election; persons employed by the State or Federal government and their spouses or dependents who are within the territorial limits

of the United States or the District of Columbia but absent from their municipality of residence. Provided further that any of the preceding qualified electors who become ill or are called away from home by business or duties, which fact was not known or could not reasonably be known prior to the preceding date, are entitled to execute and file an Emergency Application any time prior to 8:00 PM on the day of the primary. The county boards of elections will supply the forms.)

- MAY 26 From this day, the county boards of elections shall make the Registered Absentee and Mail-in Voters File available for public inspection, until the day following the primary or election or the day the county board certifies the returns, whichever date is later.
- MAY 26 From this day and until the returns are certified, the county boards of elections shall post the Military, Veterans and Emergency Civilian Absentee Voters' list.
- MAY 28 Not later than this day, the county boards of elections shall make available for public inspection the forms of the ballots and ballot labels which shall be used in each election district at the primary election and shall publish on their website.

- JUNE 5 No later than 9:00 AM on this day, the Return Boards must begin to canvass, and compute returns of the votes cast.


Candidates who file nomination petitions to access the Municipal Primary Ballot.

The filing fees and the number of signatures that are required on nomination petitions for offices to be filled at the 2020 Elections are as follows:

1. President of the United States	\$200	2,000
 Attorney General Auditor General Treasurer 	\$200	1,000 (including at least 100 from each of at least 5 counties)
5. Representative in Congress	\$150	1,000
6. Senator in the General Assembly	\$100	500
7. Representative in the General Assembly	\$100	300
8. Delegate to a National Party- Convention	\$25	250
9. Alternate Delegate to a National Party Convention	\$25	250

Candidates who file Nomination Papers to access the Municipal Election Ballot.
