CEASE AND DESIST ORDER

AND NOW, THIS 17th DAY OF JANUARY, 2017, THE SECRETARY OF THE COMMONWEALTH, HAVING FOUND THAT CATHOLIC MARKETING COMPANY, LLC., 6440 SKY POINT DRIVE, STE 140-441, LAS VEGAS, NEVADA 89131, IS NOT REGISTERED WITH THE DEPARTMENT OF STATE'S BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS, THAT CATHOLIC MARKETING COMPANY, LLC., HAS FAILED TO COMPLY WITH THE ORDER OF THE SECRETARY ISSUED ON AUGUST 14, 2015, AND HAS FAILED TO RESPOND TO THE DEPARTMENT'S REQUESTS FOR COMPLIANCE WITH SAID ORDER; IN ACCORDANCE WITH THE PENNSYLVANIA SOLICITATION OF FUNDS FOR CHARITABLE PURPOSES ACT, 10 P.S. § 162.1 *ET SEQ.*, HEARBY ORDERS CATHOLIC MARKETING COMPANY, LLC. TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN PENNSYLVANIA UNTIL SUCH TIME AS IT FULLY COMPLIES WITH THE AUGUST 14, 2015 AJUDICATION AND ORDER ISSUED BY THE SECRETARY OF THE COMMONWEALTH. ADDITIONALLY, CATHOLIC MARKETING COMPANY, LLC. MAY BE SUBJECT TO ADMINISTRATIVE FINES OF UP TO \$1,000 PER VIOLATION OF THE ACT AND \$100 FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
