

Acting Secretary of State Robert Torres announced that 9 disciplinary actions have been taken against charitable organizations, professional solicitors and professional fundraising counsel by the Bureau of Corporations and Charitable Organizations.

Actions

Berks County

Muhlenberg Township Athletic Association, 4000 10th Avenue, Temple, PA 19560, paid a \$6,000.00 administrative fine as the result of violating the Pennsylvania Solicitation of Funds for Charitable Purposes Act at Section 15(a)(1) of the Act, 10 P.S. § 162.15(a)(1), by and through 10 P.S. § 162.5(a), by soliciting contributions without the approved registration filed with the Bureau after it received contributions in excess of \$25,000.00 per annum.

Bucks County

Poverty Resolutions, Inc., 3325 Penn Estates, 3488 York Road, Furlong, PA 18925, paid a \$3,000.00 administrative fine as the result of violating the Pennsylvania Solicitation of Funds for Charitable Purposes Act at Section 15(a)(1) of the Act, 10 P.S. § 162.15(a)(1), by and through 10 P.S. § 162.5(a), by soliciting contributions without the approved registration filed with the Bureau after it received contributions in excess of \$25,000.00 per annum.

Respondent also agreed to reimburse a former donor \$49,169.00 of a \$100,000.00 donation and reimburse another former donor \$2,500.00 of a \$6,000.00 donation.
