Charity Navigator provides ratings and reviews on over 8,000 charities after evaluating the financial health of these charities. The goal is to promote intelligent giving decisions.

BBB Wise Giving Alliance - www.give.org/

The BBB Wise Giving Alliance evaluates charities based on the voluntary Standards for Charity Accountability.

Internal Revenue Service - Charities & NonProfits Exempt Organization Select Check – https://www.irs.gov/Charities-&-Non-Profits/Exempt-Organizations-Select-Check

This is an online search tool that allows users to search for a charitable organization to find out if a charity:

- is exempt from federal taxation (i.e. is eligible to receive tax-deductible charitable contributions)
- has filed a Form 990-N (e-Postcard) annual electronic notice
- has had its tax-exempt status automatically revoked because it has not filed its required Form 990-series return for three consecutive years.
