### **Philadelphia County**

Shannon Mary Ward, license no. MSG006118, of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$600 and must complete a CPR course through contact hours within 90 days from the date of the order, and must complete 8 hours of acceptable continuing education, of which at least 4 hours must cover professional ethics, because she failed to complete 8 hours of acceptable continuing education with at least 4 hours in professional ethics, and failed to complete a CPR course through contact hours to bring current her CPR certification.
