Wolfgang, Esquire, Board Counsel, 19 discussed the Annex, Preamble, and notice for the 20 General Provisions regulation.] * * * 21 22 [Kathryn L. Waters, Deputy Commissioner, entered the 23 meeting at 10:16 a.m. and exited the meeting at 10:18 24 a.m.] 25 * * *

[Ms. Wolfgang noted a quorum to be present. 1 She informed the Board that the Office of General Counsel 2 3 (OGC) had reviewed the revisions to the General 4 Provisions regulation. She noted the implementation 5 date for the occupational therapy assistants (OTAs) to begin in the July 2017 biennium. Due to being in that 6 7 July 2017 biennium, the Independent Regulatory Review 8 Commission (IRRC) commented that notice had not been 9 properly provided to the OTAs, as well as noting 10 additional issues.

Ms. Wolfgang recommended pushing the regulation implementation to the 2019-2021 biennium. She suggested splitting and redrafting the Annex. Ms. Wolfgang referred to the Annex, noting the

15 change from 2017-2019 to 2019-2021. She also added 16 the word "and" on page 12. Ms. Hample, Dr. Baird, Ms. 17 Hischmann, and Ms. Gatty agreed with the change to the 18 2019-2021 biennium.

Ms. Wolfgang discussed highlighted revisions to the Preamble. She stated the Board would notify all OTAs of the new continued competency requirements via email and its newsletter after the final-form regulation was published.

24 Ms. Wolfgang referred to the notice for the 25 Board's review.
