Continuing Education Documentation

The State Board of Optometry would like to remind licensees to check their continuing education documentation to be sure that all certificates of completion/attendance provide the following information:

- ✓ Your name
- ☑ Date of the course/program
- ✓ Number of continuing education hours earned
- ☑ instructor
- ☑ Title of the course, including the course number assigned by the Board, if applicable, and description of content. For those courses which are approved to meet the requirements for therapeutic or glaucoma certification, the licensee claiming credit shall ensure that the certificate of attendance includes the course number and number of hours that apply toward the requirement for therapeutic or glaucoma certification.
- ✓ School, clinical hospital, medical center, optometric center or organization sponsoring course, clinical conference, clinical rounds or preceptor training.
- A statement that the course/program was approved by the Board or by a preapproved provider (see §23.86(a) of the Board's regulations)
