**STATE HEALTH LICENSING BOARDS
DISCIPLINARY ACTIONS
July 2007**

Secretary of the Commonwealth Pedro A. Cortés and Basil L. Merenda, Commissioner of the Department's Bureau of Professional and Occupational Affairs, announced 78 disciplinary actions taken by the following State Health Licensing Boards: Chiropractic; Dentistry; Medicine; Nursing Home Administrators; Occupational Therapy; Optometry; Osteopathic Medicine; Pharmacy; Physical Therapy; Podiatry; Psychology; Social Workers, Marriage and Family Therapists and Professional Counselors; Examiners in Speech-Language and Hearing; and Veterinary Medicine.

Actions were taken against individuals or firms in the following counties: Adams (1 action); Allegheny (5 actions); Beaver (1 action); Bucks (5 actions); Cambria (1 action); Chester (1 action); Clinton (1 action); Columbia (1 action); Delaware (1 action); Erie (1 action); Franklin (1 action); Lackawanna (3 actions); Lancaster (1 action); Lehigh (1 action); Luzerne (1 action); Montgomery (16 actions); Northampton (2 actions); Philadelphia (5 actions); Tioga (1 action); Washington (1 action); Westmoreland (2 actions); Wyoming (1 action) and York (1 action). Twenty-four actions involved Pennsylvania licenses with out-of-state addresses.

BOARD OF CHIROPRACTIC

No disciplinary actions taken.

BOARD OF DENTISTRY

Montgomery County

Richard M. Pollock, license no. DS026226L of Washington, D.C., was assessed a \$1,000 civil penalty and issued a public reprimand because his license was disciplined by the proper licensing authority of Va. (06-13-07)

BOARD OF MEDICINE

Allegheny County

Santiago L. Roig, license no. MD039915E, of Oakdale, Allegheny County, was assessed a \$1,000 civil penalty and a public reprimand was placed on his permanent board record. Roig had a license or authorization to practice revoked or suspended or had other disciplinary action taken, or an application for a license or other authorization refused, revoked or suspended by a proper licensing authority of another state, territory, possession or county, or a branch of the federal government, and failed to report disciplinary action instituted against him by a licensing authority of another state, territory, possession or county, or a branch of the federal government. Bucks County

Richard Allen Koff, license no. MD040042L, of Richboro, Bucks County, was suspended indefinitely for a period of not less than two years, immediately stayed in favor of probation subject to terms and conditions set forth in the order. Koff was assessed a \$5,000 civil penalty after he pled guilty to a felony in a federal court. (06-26-07)

Manuel Pagalilauan, license no. MD036065L of Bensalem, Bucks County, voluntarily and permanently surrendered his license. Pagalilauan was charged with drug law violations relating to his practice of medicine. (06-26-07)

Lackawanna County

Milan John Smolko, license no. MD030578E, of Clarks Summit, Lackawanna County, had his license automatically suspended for at least 10 years based on findings he was convicted of a felony under the Controlled Substance, Drug, Device and Cosmetic Act. (05-17-07)

Montgomery County

Neal Hall, license no. MD038426E, of Flourtown, Montgomery County, was assessed a \$5,000 civil penalty and had a reprimand placed on his board record. Hall was convicted of a crime which involved moral turpitude directly or indirectly affecting the welfare of citizens of this commonwealth. (06-26-07)

Steven W. Klinman, license no. MD013436E, of Elkins Park, Montgomery County, agreed to the permanent, voluntary surrender of his license because he failed to carry out the minimum standards for the prescribing of controlled substances which include a physical examination of the patient. (06-26-07)

Layne J. Molmen, license no. YM005495L, of Plymouth Meeting, Montgomery County, had his license indefinitely suspended based on findings that he is unable to practice with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence

upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. (06-06-07)

Wyoming County

John F. McIntyre, Jr., license no. MD014415E of Tunkhannock, Wyoming County, was assessed a \$2,000 civil penalty and had a reprimand placed on his board record. McIntyre engaged in unprofessional conduct by departing from, or failing to conform to, an ethical or quality standard of the profession, whereby actual injury to a patient need not be established. Out of State

David Clinton Blocker, license no. MD044976E, of Centerville, OH, was assessed a \$500 civil penalty. Blocker had disciplinary action taken against his license by the proper licensing authority of another state. A public reprimand was placed on Blocker's permanent board record. (6-26-07)

Musya Branovan, license no. MD034822E, of Los Angeles, Calif., voluntarily, irrevocably and permanently surrendered his license because he had his license disciplined in another state, and failed to report a disciplinary action taken on his license to practice medicine and surgery by another state. Zhivko N. Daskalov, license no. MD040639E, of Westwood Hills, Kan., has permanently and voluntarily surrendered his license. Daskalov had his license or other authorization to practice the profession revoked or suspended or had other disciplinary action taken against his license by the proper licensing authority of another state. (06-26-07)

George C. Ibars, license no. MD031993E of Miami, Fla., was assessed a \$5,000 civil penalty. Ibars had disciplinary action taken against his license by the proper licensing authority of another state. (06-26-07)

Daniel Luczkow, license no. MD058942L, of West Barnstable, Mass., was assessed a \$500 civil penalty because he had a license or other authorization to practice the medical profession revoked or suspended or had other disciplinary action taken, or an application for a medical license or other authorization refused, revoked or suspended by a proper licensing authority of another state, territory, possession or country, or a branch of the federal government. Dennis L. Mickleson, license no. MD027662E, of Palmer, Ark., voluntarily surrendered his license. Mickleson had his license revoked or suspended or had other disciplinary action taken, or an application for a license or other authorization refused, revoked, or suspended by a proper licensing authority of another state, territory, possession, or country, or a branch of the federal government. Ramsey N. Nassar, license no. MD034808E, of Louisville, Ky., agreed to the permanent voluntary surrender of his license. Nassar failed to complete 100 clock hours of continuing education in timely and acceptable courses and programs in the profession during the preceding biennial period. (06-26-07)

Robert Dean Phillips, license no. MD008140E, of Morris, Ala., agreed to permanently and voluntarily surrender his license because he had disciplinary action taken against his license by the proper licensing authority if another state. (06-26-07)

Jay Schwartz, license no. MD071013L, of Natchez, Miss., was placed into the Disciplinary Monitoring Unit for five years because Schwartz voluntarily surrendered his registration, and was in the past unable to practice with reasonable skill and safety to patients by reason of his abuse of alcohol and benzodiazopene. Vincent Joseph Thompson, III, license no. MD426812 of Browns Mills, N.J., was placed on indefinite probation for no less than five years and had a public reprimand placed on his permanent board record. In addition, Thompson was ordered to complete the Medical Review and Accreditation Council Inc.'s post-evaluative medical education program and abide by any recommendation proposed by or as a result of any such programming because he had disciplinary action taken against his license by the proper licensing authority of another state. BOARD OF OSTEOPATHIC MEDICINE

Adams County

Wayne H. Senft, license no. OS003005L, of Hanover, Adams County, was indefinitely suspended for no less than three years, immediately stayed in favor of no less than five years of probation. Senft is unable to practice osteopathic medicine with reasonable skill and safety to patients by reason of illness, addiction to drugs or alcohol ("impairment"), and he has violated a lawful disciplinary order of the board. Paul H. Caviness, license no. OS007697L, of Langhorne, Bucks County, had his license temporarily suspended since his continued practice presents an immediate and clear danger to the public health and safety. (06-21-07)

Montgomery County

Conrad T. Fraider, license no. OS004049L, of Bala Cynwyd, Montgomery County, was ordered to cease and desist from practice, and to not represent himself as a licensee, and not to petition or apply for reinstatement of his license. Fraider is unable to practice with reasonable skill and safety to patients by reason of mental or physical illness, drunkenness, excessive use of drugs or narcotics, chemicals, or other type of material. Fraider engaged in unprofessional conduct by engaging in sexual behavior through remarks and actions with two patients on multiple occasions. (07-11-07)

Philadelphia County

Frederick Janczuk, license no. OS004981L, of Philadelphia, Philadelphia County, agreed to voluntarily and indefinitely surrender his license. Janczuk is unable to practice with reasonable skill and safety because of a mental and/or physical condition. (07-11-07)

BOARD OF PHARMACY

Allegheny County

David Lee Kalla, license no. RP032722L, of Pittsburgh, Allegheny County, was assessed a \$1,800 civil penalty and ordered to obtain 18 hours of ACPE continuing education within six months. Kalla failed to complete 30 hours of continuing education as required by the regulations and procured a license through fraud, misrepresentation or deceit by falsely indicating that he had 30 continuing education credits. Bucks County

Dean M. Siegel, license no. RP037878L, of Richboro, Bucks County, had his license automatically suspended for being convicted of felonies under the Drug Act. (03-06-07)

Dao T. Nguyen, license no. RP040225L, of Bensalem, Bucks County, was assessed a \$2,000 civil penalty and ordered to obtain 20 hours of continuing education credits within six months. Nguyen failed to complete 30 hours of continuing education as required by the regulations and procured a license through fraud, misrepresentation or deceit by falsely indicating that he had 30 continuing education credits. Christopher Freeman, license no. RP041879L, of Mill Hall, Clinton County, was assessed a \$300 civil penalty and required to obtain six hours of continuing education credits within six months. Christopher Lee Nowak, license no. RP037595T, of Wattsburg, Erie County, was actively suspended for 10 weeks, retroactive to Oct. 18, 2005 through Dec. 28, 2005. Nowak's license was indefinitely suspended for no less than three years, immediately stayed in favor of no less than three years of probation subject to the terms and conditions set forth in the consent agreement. Nowak is unable to practice because of intemperance in the use of alcoholic beverages, controlled substances or any other substance which impairs the intellect and judgment to such an extent as to impair the performance of professional duties. Luzerne County

Stephen Eugene Dickerman, license no. RP028424L, of Kingston, Luzerne County, had his license suspended for at least five years, stayed in favor of probation, based on having been convicted of a misdemeanor relating to the practice of pharmacy. (04-23-07)

Montgomery County

Eun-Hee Ahn, license no. RP042409L of North Wales, Montgomery County, was publicly reprimanded, assessed a \$3,000 civil penalty and required to obtain 30 hours of continuing education credits within six months. Ahn failed to complete 30 hours of continuing education as required by the regulations and procured a license through fraud, misrepresentation or deceit by falsely indicating that he had 30 continuing education credits. (06-19-07)

Anthony J. Almeida, license no. RP023555L of Bridgeport, Montgomery County, was assessed a \$200 civil penalty and ordered to obtain one continuing

education credit within six months. Almeida failed to complete 30 hours of continuing education as required by the regulations. (06-19-07)

Anthony Joseph Chichearo, license no. RP024551L, of Plymouth Meeting, Montgomery County, was publicly reprimanded and assessed a \$3,000 civil penalty and ordered to obtain 30 hours of ACPE continuing education. Chichearo failed to complete 30 hours of continuing education and procured a license through fraud, misrepresentation or deceit by falsely indicating that he had 30 continuing education credits. Lisa M. Crawford, license no. RP438623, of King of Prussia, Montgomery County, was assessed a \$1,700 civil penalty and ordered to obtain 17 hours of continuing education credits within six months. Crawford failed to complete 30 hours of continuing education as required by the regulations and procured a license through fraud, misrepresentation or deceit by falsely indicating that she had 30 continuing education credits. Bruce C. Goldberg, license no. RP028053L, of Huntingdon Valley, Montgomery County, was indefinitely suspended for no less than five years, retroactive to Feb. 28, 2006. Goldberg pled guilty to a felony. (06-19-07)

Northampton County

Kimberly Lauren Aines, license no. RP438854, of Easton, Northampton County, was assessed a \$300 civil penalty and ordered to obtain six hours of continuing education credits within six months. Aines procured a license through fraud, misrepresentation or deceit by falsely indicating that she had 30 continuing education credits and by failing to complete 30 hours of continuing education as required by the regulations. Robert John Warner, license no. RP032574L, of Bethlehem, Northampton County, was assessed a \$200 civil penalty and complete one hour of continuing education credits within six months. Warner failed to complete 30 hours of continuing education and procured a license through fraud, misrepresentation or deceit by falsely indicating he had 30 continuing education credits. (06-19-07)

Philadelphia County

James P. Lezotte, license no. RP040201L, of Philadelphia, Philadelphia County, was suspended for no less than three years because he violated the terms of a previous adjudication and order. (05-11-07)

Tioga County

David Thomas Sheridan, license no. RP034867L of Johnstown, Tioga County, was assessed a \$200 civil penalty and ordered to complete one hour of continuing education credits within six months. Sheridan failed to complete 30 hours of continuing education and procured a license through fraud, misrepresentation or deceit by falsely indicating that he had 30 continuing education credits.
