**STATE BOARD OF NURSING
DISCIPLINARY ACTIONS
October 2007**

Secretary of the Commonwealth Pedro A. Cortés and Basil L. Merenda, Commissioner of the Department's Bureau of Professional and Occupational Affairs, announced 14 disciplinary actions taken by the State Board of Nursing.

Actions were taken against individuals or firms in the following counties: Blair (1 action); Bucks (1 action); Chester (1 action); Lancaster (1 action); Lackawanna (1 action); Luzerne (2 actions); Monroe (1 action); Northampton (1 action); Philadelphia (1 action); Washington (2 actions). Two actions involved Pennsylvania licenses with out-of-state addresses.

Blair County

Rebecca L. Wike, license no. PN260191L, of Tyrone, Blair County, was suspended indefinitely because she is unfit or incompetent and because she is addicted to or dependent upon drugs. (09-17-07)

Bucks County

Michele Torgerson Euster, license no. RN503137L, of Dublin, Bucks County, was suspended for no less than three years, retroactive to March 30, 2007, based on her violation of the terms of her Voluntary Recovery Program Consent Agreement of the Professional Health Monitoring Program. (05-31-07)

Chester County

Anna Maria Roselli, a/k/a Annemarie E. Roselli, license no. RN236431L, of Chester Springs, Chester County, was indefinitely suspended based upon her criminal convictions and inability to practice nursing with reasonable skill and safety to patients. (09-17-07)

Lancaster County

Beth Ann Wehner-Cintron, license no. PN260531L, of Lititz, Lancaster County, was suspended for two years based upon her criminal conviction. The entire period of suspension was stayed in favor of probation. (09-18-07)

Lackawanna County

Carol Anne Santarelli, license no. RN503001L, of Archbald, Lackawanna County, was assessed a \$500 civil penalty and placed on probation for three years based upon her criminal conviction and failure to report that conviction to the board. (09-18-07)

Luzerne County

Megan Jarrett Righter, license no. PN152251L, of Glen Lyon, Luzerne County, was indefinitely suspended based upon her failure to submit to a mental and physical examination. (09-17-07)

Lois Disque Warner, license no. RN166218L, of Mountain Top, Luzerne County, was suspended for at least two years based upon her criminal convictions. (09-17-07)

Monroe County

Melinda Lamberson Reynolds, license nos. PN100970L and RN528947L, of Pocono Summit, Monroe County, was suspended for at least three years, retroactive to May 9, 2007, because she violated an agreement by which disciplinary action was deferred while she participated in a board-approved treatment program. The remaining period of suspension was stayed in favor of probation. (09-18-07)

Northampton County

Michelle P. Boyer, license no. RN508875L, of Bethlehem, Northampton County, had her license indefinitely suspended, for at least three years, retroactive to Feb. 16, 2007, based on findings that she is unable to practice professional nursing with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. (08-24-07)

Philadelphia County

Lisa D. Delange, license no. PN256885L, of Philadelphia, Philadelphia County, had her license indefinitely suspended, for at least three years, based on findings that she is unable to practice with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. (08-28-07)

Washington County

Chynthia A. Dupain, license no. PN101282L, of Washington, Washington County, was suspended by the Washington County Court of Common Pleas on Aug. 29, 2007. The court issued the suspension, which was effective immediately, under section 4355 of the Domestic Relations Code. (09-10-07)

Jayne Silfies, license no. PN063785L, of Fredericktown, Washington County, was denied reinstatement. (9-18-07)

Out of State

Sandra Devlin Shearer, a/k/a Sandra Devlin Ali, license no. RN329710L, of Scottsdale, Ariz., was suspended for at least three years, retroactive to Oct. 5, 2006, because she violated an agreement by which disciplinary action was deferred while she participated in a board-approved treatment program. (09-12-07)

Janice B. Thompson, license no. RN317690L, of Columbus, Miss., was revoked based upon her disciplinary action in another jurisdiction. (09-18-07)
