BL052996 of Philadelphia, Philadelphia County, was suspended pursuant to the order of the Court of Common Pleas of Philadelphia County dated Feb. 9, 2009, which the court issued under section 4355 of the Domestic Relations Code. RL003182L of Meadville, Crawford County, was ordered by the Pennsylvania State Board of Certified Real Estate Appraisers to immediately and permanently cease and desist from practicing as a certified residential appraiser, and to not represent herself as a board certificateholder at any time after accepting the permanent and voluntary surrender of her appraisal certificate. This disciplinary action was imposed because in at least eight appraisal assignments she violated the Appraiser Act in that she failed to complete an appraisal assignment within the requirements of the USPAP; failed or refused to exercise reasonable diligence when she developed an appraisal, prepared an appraisal report, or communicated an appraisal report; acted negligently or incompetently when she developed an appraisal, prepared an appraisal report, or communicated an appraisal; and by willfully disregarding or violating provisions of the law or the guidelines or regulations of the board. Kristopher M. Porter, certificate no. RL003591L of Edinboro, Erie County, was ordered by the Pennsylvania State Board of Certified Real Estate Appraisers to be suspended from the practice of real estate appraising for 30 months, with a minimum active suspension of four months; the remaining suspension subject to conditional terms of probation, and to pay a civil penalty of \$2,000, costs of investigation of \$1,000, and must complete 105 hours of remedial professional education courses because he violated the Appraiser Act in three appraisal

assignments in that he failed to complete an appraisal assignment within the requirements of the USPAP; failed or refused to exercise reasonable diligence when he developed an appraisal, prepared an appraisal report, or communicated an appraisal report; acted negligently or incompetently when he developed an appraisal, prepared an appraisal report, or communicated an appraisal; and by willfully disregarding or violating provisions of the law or the guidelines or regulations of the board. This was because she violated the law in that she is unable to practice nursing with reasonable skill and safety to patients by reason of illness, addiction to drugs or alcohol, or mental impairment. PN275043 of Meadville, Crawford County, was suspended for no less than one year based on findings that she was diverting medications from her employer and from patients of her employer, and for committing fraud or deceit in the practice of practical nursing. RN323693L and PN087160L of Mechanicsburg, Cumberland County and Harrisburg, Dauphin County, had her licenses to practice professional and practical nursing indefinitely suspended based on her inability to practice nursing with reasonable skill and safety to patients. Sharon McHale Cowher, RN, license no. RN501779L of Brownsville, Fayette County, was indefinitely suspended for no less than three years, with three months of active suspension from Jan. 15, 2009 through April 25, 2009. Upon completion of the active suspension, such suspension will be immediately stayed in favor of no less than three years probation, subject to the board's terms and conditions, because Mancini is unable to practice professional nursing with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination, and she violated a lawful disciplinary order of the board. ### **Lackawanna County**

Melissa M. Fuchs, a/k/a Melissa Marie Speicher, license no. PN263280 of Peckville, Lackawanna County, had her practical nursing license indefinitely suspended retroactive to Dec. 1, 2008, based on findings that she is addicted to alcohol or is addicted to hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. Amy Marie Frick, license nos. RN544758 and SP008528, as well as Prescriptive Authority Nos. 003825, 005770 and 006048 of Scranton, Lackawanna County, had her license and certifications suspended for a period of two years, retroactive to Feb. 14, 2008, because she violated the law by failing to obtain an initial medical history and conduct an initial physical exam prior to prescribing a controlled substance. She also failed to record in the patient's medical record the name of the controlled substance, its strength, the quantity, the date it was prescribed, the symptoms observed and reported, the diagnosis or the condition for which the controlled substance was given, and the directions given to the patient for the use of the controlled substance. In addition, she has been convicted, or has pleaded guilty, or entered a plea of nolo contendere, or has been found guilty by a judge or jury, of a felony or a crime of moral turpitude, or has received probation without verdict, disposition in lieu of trial or an accelerated rehabilitative disposition in the disposition of felony charges, in the courts of this Commonwealth, the United States, or any other state, territory, possession or country. ### **Lehigh County**

Mary Reilly, license no. RN583258 of Allentown, Lehigh County, had her professional nursing license reinstated to probationary status for at least five years subject to monitoring by PHMP's Disciplinary Monitoring Unit, based on findings that there was no evidence to suggest that she compromised sobriety, but bowed to pressure into the part of the breach related to Schedule III and IV controlled substances in order to keep her job. Stacy L. Schrammel, license no. PN256551L of Emmaus, Lehigh County, had her nursing license suspended for no less than three years retroactive to Jan. 15, 2009, based on findings that she violated the terms of the voluntary recovery program consent agreement. (02/20/09)
