



DISCIPLINARY ACTIONS May 2010

## **PA Board of Accountancy**

## **Bucks County**

Institute of Management Accountants Main Line Chapter, license no. PX000423L of Southeastern, Bucks County, agreed to a civil penalty of \$2,000 because it failed to renew its approval to offer continuing education courses. (04/20/10)

## **Mercer County**

Sarah R. Clover, license no. CA042209L of Sharon, Mercer County, was suspended for one year effective immediately, and after a minimum of three months suspension, such suspension will be stayed in favor of probation, and she was assessed a civil penalty of \$3,000 and must complete 28 continuing professional education credits within 90 days because she engaged in fraud or deceit in obtaining a certificate of certified public accountant or in obtaining registration under the act or in obtaining a license to practice under the act by enlisting an office staff worker to complete her continuing education courses online, impersonating Clover. ## **Montgomery County**

John Joseph Cione, unlicensed of Pottstown, Montgomery County, paid a civil penalty of \$1,000 and agreed to cease and desist from any further practice as a licensee of the board, unless and until he obtains a certificate and license to practice, because he failed to hold a license to practice as a certified public accountant or public accountant in Pennsylvania. Joel Paskin, license no. CA005734L of Huntingdon Valley, Montgomery County, paid a civil penalty of \$1,100 because he continued to practice as a certified public accountant by performing accounting and tax services on seven clients on a monthly basis, seven clients on quarterly basis, and six clients on a yearly basis; prepared 11 compilations and approximately 213 tax returns when he was not currently licensed to practice. ## **Northampton County**

Lois Anne Hefferle, license no. CA034754L of Easton, Northampton County, was assessed a civil penalty of \$1,000 because Hefferle displayed a business sign and business cards indicating that she was a certified public accountant and thereby engaged in the practice of public accounting in Pennsylvania while not a current licensee. ## **Out of State**

Calvin Charles Balliet, license no. CA014017L of Irving, Texas, paid a civil penalty of \$300 because he failed to complete the requisite 20 credit hours of continuing professional education during calendar year 2006 in the biennial period, and did not complete the requisite 80 credit hours of CPE during the biennial period. Brendan Noel Dolan, license no. CA032132L of Spring Lake, N.J., was assessed a civil penalty of \$300 and shall complete 26 hours of continuing professional education in format other than self study, pursuit to continuing education regulations of the board, because Dolan failed to complete at least 80 hours of continuing

education during the biennial period from Jan. 1, 2006, to Dec. 31, 2007, in that Dolan submitted over 40 hours of individual study hours. (04/20/10)

#### **Delaware County**

Modern Hair Designs Barber Shop, license no. BO432484 of Upper Darby, Delaware County, was ordered to pay a civil penalty of \$100 because it failed to meet minimum equipment requirements. (04/19/10)

#### Philadelphia County

Fatou African Hair Gallery, license no. BO107932 of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$600 because it failed to display every license and permit issued by the board in a conspicuous place within the barber shop; did not have displayed in a conspicuous place at the shop entrance a notice to consumers listing the phone number at which a consumer may report a complaint to the State Board of Barber Examiners; was not under the immediate supervision of a manager barber or a licensee designated in charge of the shop; and failed to meet the minimum equipment requirements. Gladys Barrett Barber Shop, license no. BO048478L in Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$1,000 because the shop operated on a lapsed license. (04/19/10)

Bernabe Muniz, owner of The Spott Barber Shop, license no. BO432703 of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$900 because his shop failed to display every license and permit issued by the board in a conspicuous place within the barber shop; employed unlicensed individuals; and was not operating under the immediate supervision of a manager-barber or a licensee designated in charge of the shop. Finest Cuts, license no. BO096376L of Philadelphia, Philadelpia County, was ordered to pay a civil penalty of \$500 because it employed an unlicensed person in its barbershop. (04/19/10)

## PA Board of Certified Real Estate Appraisers

#### Allegheny County

William P. McCabe, license no. RL003656 of Allison Park, Allegheny County, was ordered to pay a civil penalty of \$3,000, \$500 for the costs of investigation, and to

attend and successfully complete at least 45 hours of remedial education because he violated the practice act by failing to complete an appraisal assignment within the requirements of the Uniform Standards of Professional Appraisal Practice, failing or refusing to exercise reasonable diligence in developing an appraisal, preparing an appraisal, or communicating an appraisal, and by negligently or incompetently developing an appraisal, preparing an appraisal report, or communicating an appraisal. ## **Dauphin County**

John H. Troup, certificate nos. RL000001L and BA003742L of Harrisburg, Dauphin County, was suspended for a minimum period of six months. The suspension may be terminated upon the payment of a civil penalty of \$4,000, costs of \$1,000 and proof of having passed the residential real estate appraiser certification examination. After the termination of the active period of suspension, Troup's certificates will be placed on probation for 12 months with relevant terms and conditions. In addition, the first six months of the probation will be served under the supervision of a mentor, who must cosign any reports prepared by Troup. The discipline was imposed because he failed to prepare an appraisal report in compliance with the requirements of the Uniform Standards of Professional Appraisal Practice. (05/05/10)

## **Bureau of Charitable Organizations**

#### **Beaver County**

Daniel Advertising, Inc. of Beaver County was ordered to pay an administrative fine of \$1,500 for violating the Solicitation of Funds for Charitable Purposes Act by contracting with a charitable organization to solicit contributions in Pennsylvania without first registering as a professional solicitor and failing to file a copy of the contract with the Bureau of Charitable Organizations. ## **Butler County**

Kenneth Evanoski Associates, a/k/a E&A, of Butler County was ordered to pay an administrative fine of \$5,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to register with the Bureau of Charitable Organizations prior to rendering soliciting services; failing to file a contract with the bureau prior to rendering soliciting services; and failing to file campaign report when required. (03/03/10)

## **Dauphin County**

Gladys Kleinfelter of Dauphin County was issued a public reprimand for violating the Solicitation of Funds for Charitable Purposes Act by breaching the fiduciary duty she owed to the Middletown Volunteer Fire Department Auxiliary. (04/19/10)

Middletown Volunteer Fire Department Auxiliary of Dauphin County was ordered to pay an administrative fine of \$1,500 for violating the Solicitation of Funds for Charitable Purposes Act by failing to produce any records or to disclose any information required to be disclosed under this act or the regulations of the department after being requested to do so and by failing to keep true and accurate records. ## **Delaware County**

Delaware County SPCA of Delaware County was ordered to pay an administrative fine of \$6,000 for violating the Solicitation of Funds for Charitable Purposes Act by soliciting charitable contributions in Pennsylvania without being registered. (03/25/10)

#### Lehigh County

Tom Kwiatek and Associates d/b/a SponsorLink of Lehigh County was ordered to pay an administrative fine of \$4,000 and ordered to submit to the Bureau of Charitable Organizations any and all overdue contracts and campaign financial reports within 30 days of the consent agreement for violating the Solicitation of Funds for Charitable Purposes Act by failing to register as a professional solicitor with the Bureau of Charitable Organizations prior to rendering solicitation services, failing to file multiple contracts with the bureau prior to rendering solicitation services and failing to file multiple campaign reports within 90 days after a solicitation campaign or event was completed or on the anniversary of a campaign or event lasting more than one year. #### **Luzerne County**

Wilkes-Barre Township Volunteer Fire Department of Luzerne County was ordered to pay an administrative fine of \$2,000 for violating the Solicitation of Funds for Charitable Purposes Act by failing to keep true and accurate records and failing to produce any records or to disclose any information required to be disclosed under the act or regulations of the Department of State after being requested to do so. #### **Out of State**

American Children's Society, Inc., of Marlboro, N.J., was ordered to pay an administrative fine of \$5,000 for violating the Solicitation of Funds for Charitable Purposes Act by soliciting charitable contributions in Pennsylvania without being properly registered, for soliciting contributions in direct violating of a cease and desist order, and for refusing or failing, after notice, to produce records of the organization to the department. Cell Phones for Soldiers, Inc., of Norwell, Mass., was ordered to pay an administrative fine of \$3,000 for violating the Solicitation of Funds for Charitable Purposes Act by soliciting charitable contributions in Pennsylvania without being registered, by failing to keep true and accurate records and by violating a cease and desist order. (04/21/10)

Vehicle Donation Processing Center, Inc., of Monrovia, Calif., was ordered to pay an administrative fine of \$7,500 for violating the Solicitation of Funds for Charitable Purposes Act by failing to file a contract with the Bureau of Charitable Organizations prior to commencement of each solicitation campaign, soliciting contributions on behalf of a charitable organization that is not registered with the bureau as a charitable organization, making a material false statement on two solicitation notices required to be filed with the bureau and failing to file campaign financial reports as required. ## Allegheny County

Lauretta Armstead, license no. CO122495L of Pittsburgh, Allegheny County, was ordered to pay a civil penalty of \$500 because she operated an unlicensed facility. (03/01/10)

Tamisha Cox, license no. CL178629 of Pittsburgh, Allegheny County, was ordered to pay a civil penalty of \$500 because she practiced nail technology in a place other than a licensed cosmetology salon or a salon limited to nail technology. (04/12/10)

NY T Nail Design, license no. CY107480 of Pittsburgh, Allegheny County, was assessed a civil penalty of \$700 because it failed to sanitize tools that come into contact with a client immediately after each use and maintain in a sanitary condition at all times, practiced nail technology in a grossly incompetent and/or unethical manner through the use of metal rasp tools, and failed to have the minimum equipment needed for a nail technology salon. #### **Berks County**

Salon 500, license no. CB090820L of West Reading, Berks County, was ordered to pay a civil penalty of \$500 because it practiced as a cosmetology salon when it was not currently licensed and registered under the practice act. (04/05/10)

#### **Chester County**

Panache Salon & Day Spa Inc, license no. CB117676 of Phoenixville, Chester County, was ordered to pay a civil penalty of \$100 because it violated the practice act in that it failed to have the minimum equipment needed for a cosmetology salon. (03/01/10)

#### **Dauphin County**

Mikshu Patel and Valaji Threading-Harrisburg East Mall, unlicensed of Harrisburg, Dauphin County, were ordered to pay a civil penalty of \$1,000 and must cease and desist from maintaining a salon until that time in which the appropriate license has been obtained from the State Board of Cosmetology because they maintained an unlicensed cosmetology shop. #### **Delaware County**

Lan's Nails #2, license no. CY193499 of Wayne, Delaware County, was ordered to pay a civil penalty of \$2,850 because it violated the act in that it practiced nail technology in a grossly incompetent or unethical manner through the use of razor tools in the practice of nail technology; failed to have a closed storage area for soiled towels; and in that it failed to maintain tools that come into contact with a client in a sanitary condition at all times. Modern Nails Salon, license no. CY104427L of Lansdowne, Delaware County, was assessed a civil penalty of \$3,000 because it practiced nail technology in a grossly incompetent manner through the use of metal rasp tools and razor scraper tools in the practice of nail technology. (05/03/10)

E Nails by Khanh, license nos. CZ115567 and CY193218 of Aston, Delaware County, was assessed a civil penalty of \$1,200 because E Nails By Khanh esthetician salon failed to have a covered waste container; and the nail technology salon failed to have a closed towel cabinet for clean linen, to have a closed storage area for soiled linen, to have a first aid kit that contained all required items, to maintain a safe, orderly and sanitary condition, failed to maintain tools that come into contact with a client in a sanitary condition at all times, and practiced in a grossly incompetent or unethical manner through the use of razor blades in the practice of nail technology. ## Lancaster County

Blades Salon, license no. CB100552L of Lancaster, Lancaster County, was accessed a civil penalty of \$1,300 because it used razor tools, failed to have a closed towel cabinet for storage of clean towels, failed to maintain tools that come into contact with a client in a sanitary condition at all times and did not maintain the salon in a safe, orderly or sanitary condition. ## **Monroe County**

Glamor Nail Spa, LLC t/d/b/a Glamor Nail Spa, license no. CY195490 of Tannersville, Monroe County, was ordered to pay a civil penalty of \$1,000 because Glamor Nail Spa, LLC, while trading and doing business as Glamor Nail Spa, permitted an unlicensed individual to perform cosmetology services in the salon and it maintained an unlicensed cosmetology shop by providing waxing services to a client on a premises not licensed for the provision of those services. ## **Philadelphia County**

Cleopatra II Beauty Salon, license no. CB121250 of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$1,100 because it failed to have a designated person in charge of the salon during regular business hours and aided and abetted the unlicensed practice of the profession. Queen's Nail Salon, license no. CY195519 and CO259672 of Philadelphia, Philadelphia County, was ordered to pay a civil penalty of \$2,500 because it practiced nail technology in a grossly incompetent or unethical manner. (04/12/10)

Chaqlis Choice LLC, license no. CB097490L of Philadelphia, Philadelphia County, was assessed a civil penalty of \$500 because it advertised or caused to be advertised on the Internet and in the Yellow Book as a cosmetology school without first having obtained a cosmetology school license from the board. (05/03/10)

#### Westmoreland County

Geraldine Werner, license no. CO233420L of Export, Westmoreland County, was ordered to pay a civil penalty of \$500 because Werner practiced as a cosmetologist when she was not currently licensed and registered under the practice act. (04/12/10)

Ngan Thuy Luu, license no. CL180451, of Nottingham, Md., had her license declared null and void and she was ordered cease and desist the practice of the profession because she procured a license to practice as a nail technician by dishonest or unethical means in violation of the licensing requirements set forth in the act. Cuc Kim Tran, license nos. CL179510 and CQ111607 of Pikesville, Md., had licenses permanently revoked because Tran procured a license to practice as an esthetician by dishonest or unethical means. (05/03/10)

This is because Norris failed to complete 100 hours of continuing education credits for the Jan. 1, 2005, through Dec. 31, 2006 reporting period. (04/27/10)

MD033076E of Philadelphia, Philadelphia County, was publicly reprimanded; ordered to pay a civil penalty in the amount of \$5,000; and ordered to complete six contact hours of continuing medical education relating to record keeping because he failed to maintain medical records for patients for the required period of time. ## York County

Michael J. Dobish, license no. MD018123E of Dallastown, York County, voluntarily surrendered his license because he was charged with drug law violations relating to his practice of medicine. (04/27/10)

## Out of State

Scott Adam Boden, license no. MD426352 of West Hartford, Conn., was ordered to pay a civil penalty of \$1,500 because he was disciplined by the proper licensing authority of another state and failed to report information regarding disciplinary action taken against him by a health care licensing authority of another state within 60 days after its occurrence. Conrado J. Miranda, IV, of Burgaw, N.C., had his license revoked in which he may reapply for reinstatement after five years. Carroll, of Broomall, Delaware County, had her notary commission suspended for a period of three months, with the suspension stayed in favor of three months probation, a civil penalty of \$500, an assessment of \$150 for the costs of continued probationary monitoring and the attendance at a notary education practice and procedure course because she failed to complete the commissioning process for her 2005-2009 notary appointment by not recording her bond at the office of the recorder of deeds of the county in which she maintains an office, not taking her oath of office and not registering her signature at the office of the recorder of deeds of the county in which she maintains an office. #### **Northampton County**

Mary C. Bishop, notary public of Northampton, Northampton County, had her commission revoked. The action was based on her failure to know through personal knowledge or have satisfactory evidence that the persons appearing before her were the persons described in and who were executing the instruments; lack of good character, integrity and ability; and failure to maintain an accurate, chronological register of her official acts, in violation of sections 3, 12.1(a) and 15(a) of the Notary Public Law, 57 P.S. §§ 149, 158.1(a) and 161(a). Dakin P. Burgess, license no. RN354840L of Pittsburgh, Allegheny County, was suspended for no less than five years, retroactive to Jan. 7, 2010, with the ability to apply for reinstatement to probation after 18 months active suspension, because he is unable to practice nursing with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol and narcotic drugs. Paul L. Johnston, license no. RN581566 of Natrona Heights, Allegheny County, voluntarily surrendered his professional nursing license because he violated the act by being unable to practice the profession with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. ## **Berks County**

Lynn Marie Toub, license no. PN086900L of Boyertown, Berks County, had her license indefinitely suspended for no less than three years, immediately stayed in favor of no less than three years probation, because she violated the act by being addicted to alcohol or hallucinogenic or narcotic drugs which tend to impair judgment or coordination. Rhonda Boerner Churico, license no. RN521334L of Wyomissing, Berks County, had her license indefinitely suspended for no less than three years, retroactive to Sept. 28, 2009, because Churico violated the act by being unable to practice the profession with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination, and by violating a lawful disciplinary order of the board. Francine H. Perna, license no. RN310712L of Douglassville, Berks County, was indefinitely suspended for no less than three years, with such suspension immediately stayed in favor of no less than three years of probation, because Perna was unable to practice the profession with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic, or narcotic drugs or other drugs which tend to impair judgment; and she was convicted, or has pleaded guilty, or entered a plea of no contest, or has been found guilty by a judge or jury, of a felony or a crime of moral turpitude, or has received probation without verdict, disposition in lieu of trial or an accelerated rehabilitative disposition in the disposition of felony charges, in the courts of this commonwealth, the United States or any other state, territory, possession, or country. ## **Bucks County**

Maun Flanagan Hunsberger, license no. RN246377L of Levittown, Bucks County, was suspended for no less than four years because Hunsberger violated the Professional Nurse Law in that she has been convicted, or has pleaded guilty, or entered a plea of no contest, or has been found guilty by a judge or jury, of a felony or crimes of moral turpitude in the courts of this commonwealth; in that she had her license suspended or revoked or has received other disciplinary action by the proper licensing authority in another state, territory, possession or country; and in that she is unable to practice nursing with reasonable skill and safety to patients by reason of mental or physical illness or condition or physiological or psychological dependence upon alcohol, hallucinogenic or narcotic drugs or other drugs which tend to impair judgment or coordination. Ryan Andrew Stout, license no. RP443133 of Perkasie, Bucks County, is indefinitely suspended because he was disciplined by the proper licensing authority of another state. (04/20/10)

#### **Cambria County**

Laura Lee Digiorgio, license no.
