#### **Chester County**

Polaris Nails, license nos. CY192753 and CZ116308 of Strafford, Chester County, was assessed a civil penalty of \$3,950 because it practiced nail technology in a grossly incompetent or unethical manner through the use of metal rasp tools and razor scraper tools, failed to keep clean paper towels in a closed cabinet or towel dispenser, failed to have a covered waste container, and failed to have current licenses on the premises; the esthetician salon failed to maintain tools that come into contact with a client in a sanitary condition at all times and employed unlicensed employees. CY195224 of Aldan, Delaware County, was ordered to pay a civil penalty of \$1,700 because it practiced nail technology in a grossly incompetent or unethical manner through the use of razor blades, and failed to maintain tools in its nail technology salon and its esthetician salon in a sanitary condition at all times. CZ116041 of Newtown Square, Delaware County, was ordered to pay a civil penalty of \$5,000 because it violated the practice act by practicing nail technology in a grossly incompetent or unethical manner through the use of metal rasps, failing to store clean towels in a closed towel cabinet, failing to store soiled towels in a closed storage area, failing to have a first aid kit that contained all the required items, and failing to maintain clean workstations. #### Lancaster County

Artstic Beauty Salon, license no. CB105904L of Lancaster, Lancaster County, was ordered to pay a civil penalty of \$500 because it practiced cosmetology in a grossly incompetent or unethical manner through the use of a credo razor tool in the salon. (06/07/10)

Lori A. Kinney, t/d/b/a Artistic Edge Salon, license nos. CB105809L and CM014312L of Myerstown, Lebanon County, was ordered to pay a civil penalty of \$500 because Kinney, while trading and doing business as Artistic Edge Salon, used razor tools in the practice of cosmetology. (06/07/10)
