MSG002609, of Boothwyn, Delaware County, was ordered to cease and desist from hiring or employing any individual to perform or offering to perform any activity requiring a license to practice as a massage therapist who does not have a license or authorization to practice issued by the board unless or until the board issues such individual the appropriate authorization; pay a civil penalty of \$1,000 and costs of investigation of \$37.01; and complete at least four hours of continuing education on the topic of ethics because he knowingly aided, assisted, hired, or advertised an unlicensed individual in the unlawful practice of massage and employed an individual as a massage therapist even though she was not licensed by the board at the time.
