Molly Rissmiller, of Bradford, McKean County, was ordered to cease and desist from holding herself out as a veterinary technician and/or providing veterinary medical care requiring a license, registration or certification from the Pennsylvania State Board of Veterinary Medicine; was levied a civil penalty of \$5,000, and costs of investigation of \$942, because she held herself out as a Veterinary Technician and engaged in the practice of veterinary medicine without being properly licensed or certified to do so.
