Brock Hohman, unlicensed, of McConnellsburg, Fulton County, must cease and desist from practicing veterinary medicine without the required license or otherwise being exempted from licensure, levied costs of investigation of \$105.35, and a civil penalty of \$3,000 was imposed but was stayed so long as he complies with the requirement to cease and desist from engaging in the unlicensed practice of veterinary medicine, because he performed a caesarian section on a sheep in labor without the required license.
