Ronald Dean Hodges, license no. BV007093L, of Bethlehem, Northampton County, was levied a civil penalty of \$2,500; costs of investigation of \$3,409; and he must complete the following courses through drip vet: Veterinary Law and Ethics and Medical Record Keeping, because he departed from the standards of acceptable and prevailing veterinary medical practice and by violating the Board's record keeping regulations.
