Jose Castillo-Martinez, notary commission no. 1275127, of Harrisburg, Dauphin County, voluntarily surrendered Castillo-Martinez's notary commission because Castillo-Martinez failed to maintain a notarial journal, charged fees in excess of schedule set by the Commonwealth for notarial acts, failed to include required information on a certificate of notarial act, and represented that Castillo-Martinez could practice law, provide legal advice, or assist persons in the preparation of legal documents. #### **Montgomery County**

Diana Zapata, notary commission number 1277736, of King of Prussia, Montgomery County, had her commission revoked and she is prohibited from reapplying for appointment and commission as a notary public for a period of four years, based on her guilty plea to two counts of Tamper Records or Id-Writing, both first-degree misdemeanors. Respondent is also subject to disciplinary action in that she failed to give a certified copy of her journal to a person requesting

it and she failed to deliver her journal to the office of the recorder of deeds where she last maintained an office. Respondent is subject to disciplinary action under the Revised Uniform Law on Notarial Acts, 57 Pa.C.S. §323(a), in that Respondent lacks the honesty, integrity, competence, or reliability to hold the office of notary public.

Michael J. Grimes, notary commission no. 1205806, of King of Prussia, Montgomery County, agreed to the suspension of Grimes's notary commission for six months, immediately stayed in favor of probation; pay an administrative penalty of \$500; pay a probation assessment of \$300; and complete six hours of remedial education because Grimes failed to maintain a journal in chronological order of all notarial acts performed in the format and manner required. John Edgar Farmer, D.O. of Waynesboro, Franklin County, Pennsylvania, agreed to the permanent voluntary surrender of Farmer's license to practice osteopathic medicine and surgery, license no. OS003716L, because Farmer engaged in unprofessional conduct. (12/12/23)

PP410228L, and Wayne Charles Sartorio, R.Ph., license no RP044686R of Kennett Square, Chester County, were ordered to pay a joint and severable civil penalty of \$2,000, because Boothwyn Pharmacy, LLC and Wayne Sartorio, R.Ph., violated the Act in that Boothwyn Pharmacy failed to be in accordance with the current version of the USP chapters governing compounding, as evidenced by an employee technician's failure to ensure proper sanitization in his compounding methods and evidenced by the existence of uncapped bottles or bottles with measuring syringe still attached on shelves in the non-sterile compounding clean room; Wayne Sartorio, as the pharmacist manager violated the Act because Sartorio failed to ensure there were no expired medications in Boothwyn Pharmacy's active drug stock. CVS Pharmacy 1920, permit no. PP414316L, and Eric A. Smith license no.; RP453591 of Lebanon, Lebanon County were ordered to pay a civil penalty of \$3,000.00 and costs of investigation of \$127.27, because CVS Pharmacy 1920 violated the Act by failing to maintain the pharmacy in a clean and orderly condition as evidenced by excessively dirty/dusty shelves; and because Respondent Smith violated the Act by failing to remove from active stock a drug whose expiration has passed.

RP445936, of Philadelphia, Philadelphia County, were levied a joint and severable civil penalty in the amount of \$7,000 and ordered to also pay a joint and severable costs of investigation in the amount of \$555.10, because Global Pharmacy Inc. and Zachary John Schmehl allegedly created unauthorized phoned-in prescriptions to bill several patients' insurance companies for medications that were not prescribed and/or delivered to the patients, which is a departure from the acceptable and prevailing standards of pharmacy practice. Broad & Grange Pharmacy, permit no. PP481783, of Philadelphia, Philadelphia County, and Roseland N. Ntege, license no. RP034333R, of Narberth, Montgomery County, were levied a joint and severable civil penalty of \$6,000; joint and severable cost of investigation of \$560.93; and received a reprimand on their permanent disciplinary records with the Board, because they had an open prescription area of the pharmacy without a licensed pharmacist on duty, had prescriptions on file which failed to show the name or initials of the dispensing pharmacist and failed to show the DEA number of the prescriber, both the pharmacy and equipment were not maintained in a clean and orderly condition and/or in good repair, they failed to maintain a signed written protocol for a pharmacy technician; the pharmacy manager knowingly allowed unlicensed personnel to take charge of the pharmacy or engage in the distribution or dispensing of prescriptions without supervision, and they failed to ensure the pharmacy was open to the public and open for inspection by an agent of the Board during posted business hours. Pharmacy Services America, Inc t/d/b/a Pharmacy Services America, registration no. NP001432, of Rocky Mount, VA, was revoked for being disciplined by the proper licensing authority of another state. (11/14/23)

Mark Stephen Reinhard, RPh license no. RP029144L and authorization no. RPI010126, of Mooresville, North Carolina, had his license to practice pharmacy and authorization to administer injectables revoked for being convicted of a crime in connection with the practice of pharmacy. (11/13/23)
