# CALENDAR FOR THE SPECIAL ELECTION TO BE HELD NOVEMBER 2, 2021 REPRESENTATIVE IN THE GENERAL ASSEMBLY FOR THE 113TH DISTRICT IN THE COUNTY OF LACKAWANNA

1.	Writ, prepared by presiding officer, served on the Secretary of the Commonwealth
2.	First day for political parties and minor political parties to nominate candidates by filing nomination certificates
3.	First day for political bodies to circulate and file nomination papers nominating candidates
4.	Last day to file nomination certificates and nomination papers
5.	Last day to file objections: 3 days after the deadline for filing September 16, 2021 (25 P.S. § 2782)
6.	Last day for Commonwealth Court to set a hearing on objections: 7 days after deadline for filing
7.	Last day to withdraw: 7 days after the deadline for filing September 20, 2021 (25 P.S. § 2783)
8.	Last day to file substituted nomination certificates: 7 days after the deadline for filing
9.	Last day to file objections to substituted nominations: 3 days after substituted nomination certificate is filed
10.	Last day for Secretary of the Commonwealth to certify names and residence of all candidates

#### ADDITIONAL INFORMATION

- A. Political Parties, including Minor Political Parties, file nomination certificates, nominating candidates in accordance with party rules.
- B. Candidates of political bodies file nomination papers, obtaining signatures equal to 2% of the largest vote cast for any elected officer in that district at the last preceding election or the number of signatures required on a nomination petition for a political party candidate, whichever is greater. Signers of such papers must be qualified, registered electors of the district. The number of signatures required on nomination papers to be filed by candidates of political bodies for the Special Election for the 113th Legislative District is 407. All nomination papers must be accompanied by a properly completed candidate's affidavit and a copy of the Statement of Financial Interests required to be filed with the State Ethics Commission. In addition, a filing fee of \$100.00 must be submitted with each set of nomination papers and must be paid by certified check or money order payable to the 'Commonwealth of Pennsylvania'.
- NOTE: The Election Code provides that no person "who is a registered and enrolled member of a party (shall) be eligible to be the candidate of a political body for a special election." 25 P.S. § 2911.1.

## CAMPAIGN FINANCE REPORTING DEADLINES

Report Complete Up To Filing Deadline\*

And Including

2nd Friday Pre-Election October 18, 2021 October 22, 2021

(Complete as of 15 days prior to the election. 25 P.S.  $\S$  3246(d)).

24 Hour Reporting October 18 (begins) November 2, 2021 (end/includes)

30 Day Post-Election November 12, 2021 December 2, 2021

(Complete as of 10 days after the special election. 25 P.S. § 3246(e))

## ETHICS LAW INFORMATION

All candidates for the Special Election must file Statements of Financial Interests with the State Ethics Commission and a copy of the Statement of Financial Interests with their nomination certificates or nomination papers. <sup>\*</sup>Postmarks are acceptable as proof of timely filing when reports are postmarked by the U.S. Postal Service no later than the day before the filing deadline.
