2.	First day for political parties and minor political parties to nominate candidates by filing nomination certificates
3.	First day for political bodies to circulate and file nomination papers nominating candidates
4.	Last day to file nomination certificates and nomination papers
5.	Last day to file objections: 3 days after the deadline for filing
6.	Last day for Commonwealth Court to set a hearing on objections: 7 days after deadline for filing September 20, 2021 (25 P.S. § 2782)
7.	Last day to withdraw: 7 days after the deadline for filing September 20, 2021 (25 P.S. § 2783)
8.	Last day to file substituted nomination certificates: 7 days after the deadline for filing
9.	Last day to file objections to substituted nominations: 3 days after substituted nomination certificate is filed Depends on filing date (25 P.S. § 2785)
10.	Last day for Secretary of the Commonwealth to certify names and residence of all candidatesOctober 3, 2021 ( <i>30<sup>th</sup> day preceding the day fixed for the special election. 25 P.S. § 2786</i> )

11.	Last day to register to vote before the electionOctober 18, 2021 (15 days before the election. 25 P.S. § 3071(b))
12.	Last day before the election on which official applications for civilian absentee ballots and mail-in ballots may be received by the county board of electionsOctober 26, 2021 ( <i>Tuesday before election. 25 P.S. §§ 3146.2a(a) and 3150.12a(a)</i> )
13.	All civilian absentee ballots must be received by the county board of elections no later than 8:00 P.M. on this day to be countedNovember 2, 2021 ( <i>On the day of the special election. 25 P.S. § 3146.6(a)</i> )
14.	All mail-in ballots must be received by the county board of elections no later than 8:00 P.M. on this day to be countedNovember 2, 2021 ( <i>On the day of the special election. 25 P.S. § 3150.16(c)</i> )

# ADDITIONAL INFORMATION

- A. Political Parties, including Minor Political Parties, file nomination certificates, nominating candidates in accordance with party rules.
- B. Candidates of political bodies file nomination papers, obtaining signatures equal to 2% of the largest vote cast for any elected officer in that district at the last preceding election or the number of signatures required on a nomination petition for a political party candidate, whichever is greater. Signers of such papers must be qualified, registered electors of the district. The number of signatures required on nomination papers to be filed by candidates of political bodies for the Special Election for the 164th Legislative District is 488. All nomination papers must be accompanied by a properly completed candidate's affidavit and a copy of the Statement of Financial Interests required to be filed with the State Ethics Commission. In addition, a filing fee of \$100.00 must be submitted with each set of nomination papers and must be paid by certified check or money order payable to the 'Commonwealth of Pennsylvania'.
- *NOTE:* The Election Code provides that no person "who is a registered and enrolled member of a party (shall) be eligible to be the candidate of a political body for a special election." 25 P.S. § 2911.1.
