Members of the Pennsylvania General Assembly:

June 30, 1999 marks the fourth anniversary of the enactment of the Pennsylvania Voter Registration Act (PVRA). The Pennsylvania Department of State has accomplished much in its assigned duties to administer this act. To that end, I am pleased to submit this report on behalf of the Department of State and the 67 county elections and voter registration commissions, who have worked diligently to administer this act.

In 1998, our counties accepted over 400,000 new voter registrations, which brought the Commonwealth's total voter registration population to a record of 7,291,949.

Our partnership with the Department of Transportation accounted for nearly a quarter of a million new registrations at PennDOT's photo license centers, and our Department forwarded almost 1 million changes of address to county election and voter registration commissions. Registering to vote at photo license centers is now easier than ever before as a result of improvements made by PennDOT to their computer systems and the issuing of receipts to applicants when they register to vote at the photo license centers.

We continued our work in administering the agency-based voter registration program, which included the addition of several new agencies. We offered training and supplies to all of our agencies, which accounted for over 13,000 new voter registrations in Pennsylvania.

For the second straight year, the Ridge Administration conducted a coordinated effort to encourage Pennsylvanians to be more active in the electoral process. Gov. Tom Ridge proclaimed September as Voter Participation and Awareness Month in Pennsylvania to recognize the importance of citizen involvement in the electoral process. In 1998, the Ridge Administration proudly inducted more than 1,000 Pennsylvania voters from 11 counties into the Pennsylvania Voter Hall of Fame. Since 1996, more than 3,000 voters from 21 counties have been inducted.

In 1998, our Department, in cooperation with the Department of Education, coordinated the 1998 Pennsylvania Student Mock Election. Over 100,000 students from grades K through 12 participated. Each school received a teacher's manual which provided assistance in adapting Mock Election activities into their classroom. This year's Mock Election also made it possible for schools to report their election results via the Internet.

1998 Report to the General Assembly on the Pennsylvania Voter Registration Act

June 30, 1999 marks the fourth anniversary of the signing of the Pennsylvania Voter Registration Act (PVRA). The Department of State has worked diligently with the 67 county elections and voter registration offices, as well as the affected state and local agencies, to fulfill the requirements of this historic act. This past year our Department saw an increase in voter registration to 7,291,949 and with that, an increase in our responsibilities of ensuring a fair, honest and efficient execution of the laws relating to the PVRA. To that end, the following represents a summary of several important aspects of PVRA.

Department of Transportation

The Department of State continues to work closely with the Department of Transportation (PennDOT) in the administration of the motor voter requirements of the PVRA. The PVRA provides for the opportunity for citizens of the Commonwealth to complete an application to register to vote while at photo license centers. The ease and convenience of this process continues to be a means to participate in the electoral process for a large percentage of Pennsylvanians.

The following procedures are followed when applying to register to vote at PennDOT:

- PennDOT customers arrive at a photo license center with a driver's license application card, that contains a printed two-dimensional bar code. The bar code is scanned and the computer evaluates the age of the customer. PennDOT's computer system determines which customers will be at least eighteen years old by the date of the next election and asks whether they wish to register to vote. Customers who choose to apply for registration are asked to confirm their county of residence, to indicate a party preference (if they have one) and to type their telephone number and race, both of which are optional. The applicant is advised of the penalty for furnishing false information and is asked to sign, on an electronic keypad, a declaration that the information is true and correct to the best of the applicant's knowledge.
- The PennDOT computer system stores the completed voter registration applications and transmits the data to the Department of State's contracted vendor where the applications are electronically sorted by county, printed and mailed to the appropriate county voter registration office.

In 1998, improvements to existing procedures used to process motor voter applications were developed. The computer screens were designed to be more user friendly. In addition, issuance of a paper receipt to those individuals who apply for voter registration at the photo license centers was initiated last year. The receipt provides the applicant, and county voter registration officials, with pertinent information if there is a question regarding a motor voter registration application. In 1998, 321,536 motor voter applications were forwarded to county voter registration officials.

In addition to new applications, PennDOT provides change of address information to the Department of State, which is then forwarded to the appropriate county voter registration office. In 1998, the Department of State transmitted 850,981 changes of addresses to county voter registration officials.

Agency Registration

The Department of State continued to work with the state operated public assistance agencies and disability agencies who have been providing voter registration opportunities to their clients. These agencies include: County Assistance Offices, Women, Infants & Children nutrition clinics, District Offices of the Office of Vocational Rehabilitation, District Offices of the Bureau of Blindness & Visual Services, State Mental Hospitals and State Mental Retardation Centers.

In 1998, the agency voter registration program was expanded to include additional agencies that provide services to persons with disabilities. The new agencies include: the Area Agencies on Aging, Contractors for the Bureau of Blindness & Visual Services, Centers for Independent Living, County Mental Health and Mental Retardation Offices and Student Disability Services Offices of the State System of Higher Education.

To help these new agencies begin their programs, the Department of State developed a guide which details the responsibilities and duties of voter registration agencies. In addition to the guide, the Department of State furnished each agency with voter registration mail application forms, posters encouraging voter registration and flyers describing the voter registration process for distribution to their clients. The Department of State conducted training sessions and provided technical assistance to help these agencies implement their new programs. The Department also published a special edition of *Voter Registration Update* for the new agencies. The newsletter provides important information to each agency site coordinator regarding voter registration procedures and deadlines.

In 1998, the Department of State created an Agency Recognition Program to recognize the service provided by Commonwealth voter registration agencies and their employees. The first step of the program requires each agency site which offers voter registration opportunities to complete a self-assessment checklist and return it to the Department of State. If the checklist shows that the agency site is providing all the required voter registration services, the Secretary of the Commonwealth presents the office with a Voter Registration Achievement Certificate. Upon earning the Achievement Certificate, the agency site is then eligible to receive an award from the Secretary for outstanding voter registration service, for agencies who have gone above and beyond in providing voter registration opportunities.

Litigation Update

The Department of State continues to implement the provisions of the stipulation agreement with the United States Department of Justice and a group of private plaintiffs, concerning the Commonwealth's compliance with the National Voter Registration Act (NVRA). To that end, we continue to offer training, materials and guidance to all designated offices and programs as they provide voter registration services to their clients with disabilities. A meeting with the United States Department of Justice, the private plaintiffs and the Department of State, on May 21, 1999, was beneficial in the continuing efforts to reach a final resolution of the NVRA litigation.

In addition, as part of the Department of Justice's settlement agreement with the Department of State, in accordance with Section 1901 (b)(3) of the PVRA, counties are now permitted to send out five year notices to registered voters who have not voted or appeared to have not voted for a five year period. The notice states, among other things, that the citizen should contact the county voter registration office within two federal elections or their registration will be canceled. The notice must also include information on how to contact the county voter registration office and how to register elsewhere if the citizen has indeed moved. An important caveat to this provision is that it must be used in conjunction with, and not as an alternative to, other voter removal programs (National Change of Address and Mass Confirmation Mailing) provided for in the PVRA.

The five year notice provision is a thorough way for our counties to identify citizens who no longer reside in their jurisdiction. This information is critical in assisting the counties and correcting their voter registration lists.

Legislative Initiatives

After several meetings with election officials from the County Legislative Committee, and attendance at their 1998 conferences by Department of State staff, we have compiled the following proposed amendments to the PVRA. We continue our close working relationship with our counties as we strive to make ourselves available and ready to assist them. In addition, we provide our 67 county election and registration offices with regular updates on issues relating to all aspects of election administration.

These changes will make enforcement of the PVRA, and other related election laws, easier and more efficient in serving the citizens of the Commonwealth. In addition, throughout 1998, we continued to keep an open dialogue between our Department, members of the General Assembly and legislative staff, regarding the carrying out of this act. This open chain of communication has proven essential in formulating these initiatives.

Amendments to the PVRA:

- Include a deadline for changes of address received by the Department of Transportation to be effective for the next election.
- Eliminate the transfer of registration records from county to county if a registrant has moved to another county and the county of former residence has been notified of such change by the Department of Transportation.
- Eliminate the costly and unnecessary requirement that a county implement an annual mailing program to identify electors whose addresses may have been changed in favor of a biennial mailing program that is in conformance with the National Voter Registration Act of 1993.
- Eliminate the requirement that the Secretary of the Commonwealth set fees for public lists which are prepared and distributed by the counties.
- Change the requirement that counties provide for computer inquiries about registered voters into an option.

Amendments to the Election Code:

- Add two new sections to mirror the fail-safe voting procedures enacted by the PVRA.
- Add a section to provide for the casting of a provisional ballot pursuant to the fail-safe voting provision if a registration card does not appear in the district register. This will provide the county election officials the opportunity to verify the fact of the elector's registration before counting their ballot.
- Amend sections applicable to the district register to allow the use of a digitized signature list to mirror those corresponding sections of the PVRA.
- Provide for electors requiring assistance to sign a declaration of assistance at the time of voting, mirroring the requirements of the PVRA.

Appendices

Statistics for the period covered by this report are contained in Appendix I through Appendix VII.

- Appendix I contains voter registration figures by county and political party as of December 31, 1998.
- Appendix II contains a comparison of voter registration totals from 1996 - 1998 as of the close of registration prior to the November Elections.
- Appendix III contains data for the various voter registration methods. Total applications include new registrations, changes of address, changes of name or party regardless of whether the application was valid, rejected or a duplicate. Valid applications include only new registration applications which were accepted by the county voter registration commissions. This appendix includes a line graph depicting various methods of application from 1995 - 1998.

- Appendix IV contains data relative to list maintenance activities in the counties for the period covered by this report. These activities include the number of changes of address received from PennDOT and processed, the number of address verification notices mailed in accordance with Section 1901 (d)(2) of the PVRA, the number of five year notices mailed and the number of responses to these notices, the number of registration files marked inactive at the end of 1998, and the number of active and inactive voter registrations which were canceled. (The motor voter litigation settlement agreement permits the counties to send out five year notices in accordance with Section 1901 (b)(3) of the PVRA; these notices were not sent out prior to the settlement agreement. Therefore, data for the five year notices is only from September- December, 1998.)

- Appendix V contains data for “motor voter” applications broken down by political party. This information is provided directly from DataCard Corporation, the contracted vendor who processes the applications for the Departments of State and Transportation. These statistics relate to the number of individuals who applied to register to vote at a photo license center. Because it is a centralized computer process, statistics can be provided by political party. Also, the total number of applications as provided by DataCard may differ from the counties’ total applications received from PennDOT for a variety of reasons, including not having been received by the counties until the next reporting period.
- Appendix VI contains the number of changes of address received by PennDOT which were forwarded to the county voter registration commissions. These numbers differ from the numbers the counties report (Appendix IV) because they include all changes reported to PennDOT regardless of whether or not the individual was registered.
- Appendix VII depicts a breakdown of the distribution of the voter registration mail application.

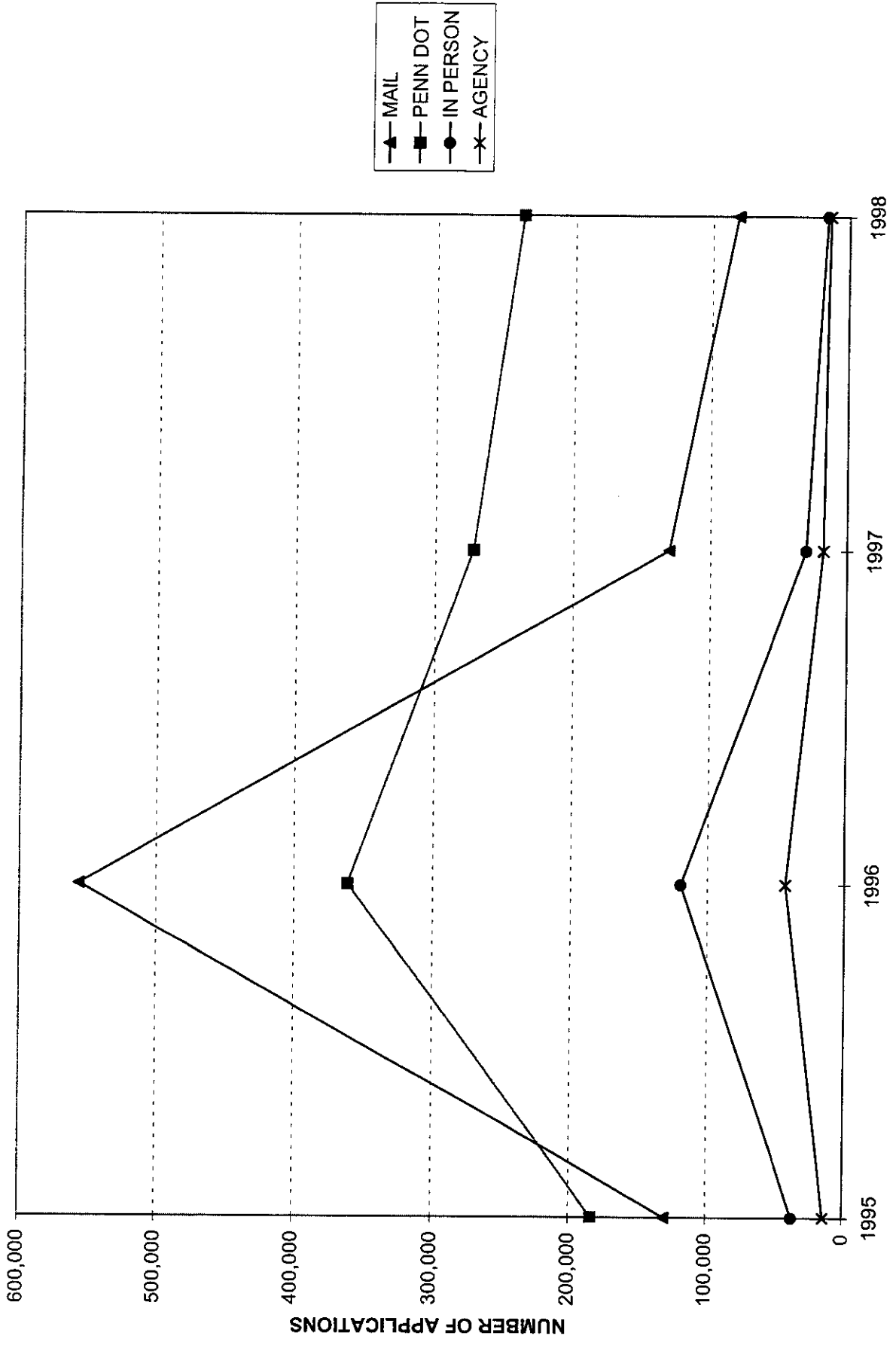
