Dear Members of the General Assembly:

As Acting Secretary of the Commonwealth, I am pleased to report on the administration of voter registration in Pennsylvania for calendar year 2020. I trust you will find this information useful.

Voter registration in Pennsylvania is a joint effort between county and state officials. In 2020, the Department of State continued its partnership with the state's 67 county election boards and voter registration commissions. In an extraordinary year, the Department supported counties in a variety of ways, including through voter education materials and through voter registration and mail ballot application forms available both in print and online in multiple languages. Our partnership with the counties resulted in record voter registration and engagement. The Department also collaborated with the state agencies designated under the National Voter Registration Act of 1993 (NVRA) to administer voter registration programs.

The Statewide Uniform Registry of Electors (SURE) system, implemented in Pennsylvania through Act 3 of 2002, is the bedrock of Pennsylvania's voter registration system. As of December 31, 2020, there were approximately 9 million registered voters in Pennsylvania. In 2020, the department began its work to update the aging SURE system and is working closely with county officials to implement the system in time for the 2022 election cycle.

The Department remains committed to fulfilling its responsibilities under the NVRA and Pennsylvania's Voter Registration Law. The Department will continue to promote voter registration and civic engagement through its outreach efforts across the Commonwealth.

In 2020 the Department of State (Department) worked closely with the public, each of the 67-county boards of elections, Commonwealth agencies designated with voter registration responsibilities, and voter registration advocacy groups. This report represents a summary of statistics and initiatives that support voter registration administration in Pennsylvania. As initially mentioned in the 2019 report, the Department continued to implement historic election modernization as laid out by Act 77 of 2019 and Act 12 of 2020.

All 2020 data referenced in this report is available in its entirety within the "Annual Report Data" section starting on page 34 of this report. Data from previous years can be found in the respective annual reports, which are available online at www.dos.pa.gov.

Voter Registration Statistics

Through the Statewide Uniform Registry of Electors (SURE) system, the county boards of elections maintain a complete list of all eligible registered voters in the Commonwealth. As of December 2020, there were 9,004,104 registered voters. This was an overall increase of 455,042 voters (5.32%) since the end of the previous calendar year (December 2019), and an overall increase of 357,866 voters (4.14%) since the end of the last presidential election cycle in December 2016. The charts in this section represent a high-level snapshot of the change in voter registration over the previous calendar year or since the last presidential election cycle.


Total Voter Registration by Party

The chart below depicts change in voter registration since 2016 and whether that change represented growth or decline in general party affiliation. The 2016 data was carried over from the 2016 annual report on voter registration. Therefore, the data from 2016 is as of Dec 31, 2016.

Areas of Growth and Decline

This section is broken into two (2) parts: 1) Growth in registration, and 2) Decline in registration. For each section, the highest counties within each category are represented below with their rate of growth or decline when compared to either last year's totals or totals from four (4) years ago.

Highest Overall Registration Growth and Highest Overall Decline Since 2019 Typically, the top five (5) counties are shown for each comparison unless fewer than five (5) counties experienced a decline in registration. As shown in the breakdown below, only three (3) counties experienced a decline in registration since 2019.



Detailed Breakdown of Change since Prior Year (2019)



List Maintenance

This section depicts overall summaries of voter list maintenance conducted during the 2020 calendar year. Generally, "list maintenance" can be described as the process county election officials use to manage voter registration rolls to ensure they are accurate. Both state and county election officials follow careful and appropriate steps, in compliance with federal and state laws, to determine whether a voter should be marked as *Inactive* or removed from the registration rolls.

List Maintenance Mailings


During 2020, counties sent more than 560,000 notices: 138,090 Five-year notices; 160,542 National Change of Address (NCOA) notices; 18,812 duplicates notices; 35,510 In-State Update notices; 37,229 Out-of-State Update notices; and 172,978 Address Verification Notices (AVNs).

When reviewing list maintenance activity summaries below, the voter responses to each notice can be summarized into five (5) broad categories:

- **Non-Response**: The voter never responded to the mailed notice.
- **Undeliverable:** The notice could not be delivered via mail and was returned as undeliverable to the county board of elections.
- Returned Confirmation: The voter responded to the notice and confirmed their eligibility.
- **Moved In-County:** The voter responded to the notice and confirmed they have moved to a new address within the county.
- **Moved Out-of-County:** The voter responded to the notice and confirmed they no longer reside in the county or moved outside of Pennsylvania.


Figures in this section are only representative of actions taken by December 31, 2020. For example, if additional responses to notices were received after that date they will not be represented below as the data is only point-in-time.

2020 Five-Year Notice Responses Summary



The Five-Year Notice (FYN) is a statutorily required one-step mailing process. It is sent via forwardable mail. The purpose of this notice is to contact voters who have not had any activity on their record or have not voted within five years. Upon generation of this notice, the voter's record is updated to *Inactive* status, which begins the list maintenance window to eventually remove the voter from the registration rolls if they do not take any action or vote within a given period. The FYN provides an opportunity for the voter to respond so they may be reinstated to *Active* status. Upon a return to *Active*, the window to eventually cancel the voter record stops.


2020 NCOA Notice Summary



The NCOA is a statutorily required two-step mailing process. Both notices are sent via non-forwardable mail. The first mailing, based on data received from the USPS through its National Change of Address Program, is a notice which requires the voter to specify whether they have move. Then, depending on their response, county officials update their records accordingly. These notices provide an opportunity for the voter to confirm their address or provide an update with their latest information to county officials.


Following the initial NCOA notice mailing, county officials send a second notice to voters who did not respond to the first mailing or the initial NCOA notice was returned as undeliverable. These records are marked *Inactive*, which begins the list maintenance window to eventually remove the voter from the registration rolls, unless they take an action to update their record or vote within a given period. This second notice is commonly referred to as the Address Verification Notice (AVN). The period lasts until two federal general elections have passed. For example, if a voter was marked as *Inactive* in 2019 during list maintenance activities, and they do not make any changes on their record or vote, the voter would be removed after the 2022 general election. Approximately, 60,861 voters were marked *Inactive* following the 2020 NCOA list maintenance process.

2020 ERIC Duplicate Notices



As part of the Department's membership in the ERIC program, data is provided to county officials which identifies a pair of voter records that may be the same person. This includes non-cancelled records (i.e. *Active* and *Inactive* status voters) for comparison. Pairs of voter records are identified for review to confirm whether the same person is potentially registered more than one time in Pennsylvania or in another state. After review, county officials update the voter's record, depending on that voter's response to the notice. During the 2020 calendar year, approximately 18,812 duplicate notices were sent to the voter's address on record.


2020 ERIC In-State Moves



Like other list maintenance mailing processes, data from the ERIC program that identifies potential updates to voter records where a voter may have moved to another location is provided to counties. This type of ERIC program data shows information where a voter within Pennsylvania appears to have newer information from another record set. The supplemental data set is from the Pennsylvania Department of Transportation (PennDOT).

This process is a one-step mailing procedure. Once the notice is queued and confirmed, the affected voter records are updated to *Inactive* status. Depending on the response to the mailer or non-response, the voter's record may be updated to *Active*, remain in *Inactive* status, or be *Cancelled*. During 2020, approximately 35,510 notices were mailed out to voters.


2020 ERIC Out-of-State Moves



The data for potential out-of-state updates or moves are provided by the ERIC program. This process captures information where a voter within Pennsylvania appears to match another record from out of state that contains newer information. This may be an indication that the voter no longer resides in the state. Therefore, any identified records are sent a notice for confirmation.


This process is a one-step mailing procedure. Once the notice is queued and confirmed, the affected voter records are updated to *Inactive* status. Depending on the response to the mailer or non-response, the voter's record may be updated to *Active*, remain in *Inactive* status, or become Cancelled. During the 2020 calendar year, approximately 37,229 notices were mailed out to voters.

2020 Address Verification Notices (AVNs)



As another method of keeping voter registration rolls accurate, county officials can send out Address Verification Notices (AVNs) to determine if the voter is still eligible to vote. In addition to the list maintenance activities described above, counties send this notice to inactive voter records when they receive an undeliverable notice at the county office after they attempt to contact the voter. For example, a voter signed up to register to vote, but the voter identification card could not be delivered by USPS. In 2020, approximately 172,978 AVNs were mailed to voters by county officials. The chart above summarizes the responses received by county officials as of December 31, 2020.

PennDOT Change of Address Summary



In addition to registering to vote through more traditional means like paper or online voter registration, the National Voter Registration Act of 1993 (NVRA) required states to incorporate voter registration opportunities into the licensing application process at state motor vehicle authorities. As part of that process, voters have an opportunity to update their voter registration with their latest information to ensure the voter registration rolls are accurate, which is otherwise known as the change of address process. During the 2020 calendar year, 394,050 change applications were submitted from PennDOT to DOS for county officials to process and update voter records. Approximately 76% of those applications resulted in an address change within the voter's existing county (move within county) and the remaining resulted in moves outside of the voter's existing county.

Voter Registration Cancellations


During 2020, the Department recorded 430,832 voter registration cancellations. When a voter registration is cancelled, the record is tagged in the SURE system to identify the reason for cancellation. County boards may cancel the registration of both *Active* or *Inactive* voters. Note: voters are marked as *Inactive* if they do not respond to a county mailing asking them to confirm their residence. For example, voters may be sent a mailing based on data the county receives in partnership with ERIC or when the voter fails to take some sort of action on their record within five years. See 25 Pa. C.S. §§ 1901(b)(1), 1901(b)(3), 1901(c).

Active Voter Registration Cancellations by Voter Status and Year

The following describes the circumstances when an active voter record would be placed into cancelled status:

Voter's Request: An active voter submits a cancellation form requesting for their voter registration to be cancelled.


Voter's Death: The county has been notified of a voter's death by the Department of Health or other state and local officials.

Other Move Confirm: The voter has confirmed with the county they have moved from the address listed on their voter registration record based on a list maintenance mailing notice; e.g. data provided from the Electronic Registration Information Center.

Canvass: The county has determined based on the Canvass investigation process the voter is not qualified to be registered to vote.

PennDOT Move Confirmed: The voter has confirmed a change of address through PennDOT.

Inactive Voter Registration Cancellations by Status and Year



^{*}In 2020, the Inactive Response to Mailing and 5 Year Notice is no longer reported individually as the counts are derived as part of Other Move Confirmed since those cancellations are related to the voter moving. Going forward, these categories will no longer be reported individually.

The following describes the circumstances when an *inactive* voter record would be placed into cancelled status:

Voter's Request: An inactive voter submits a cancellation form requesting that their voter registration be cancelled.

Voter's Death: The county has been notified of a voter's death by the Department of Health or other state and local officials.

Other Move Confirmed: The voter has confirmed with the county they have moved from the address listed on their voter registration record based on a list maintenance mailing notice; e.g. data provided from the Electronic Registration Information Center or if a voter responds to an Address Verification Notice indicating a change of address.

PennDOT Move Confirmed: The voter has confirmed a change of address through PennDOT.

Canvass: The county has determined based on the Canvass investigation process the voter is not qualified to be registered to vote.

Inactive Voter Removal Programs: Voters placed into *Inactive* status who do not have any record of activity for two federal general election cycles are cancelled following the second federal general election after becoming *Inactive*.

National Voter Registration Act (NVRA)

Total Agency Registrations

The National Voter Registration Act (NVRA) requires that "(1) Each state shall designate agencies for the registration of voters in election for Federal offices. (2) Each state shall designate as voter registration agencies – (A) all offices in the state that provide public assistance; and (B) all offices in the State that provide State-funded programs primarily engaged in providing service to persons with disabilities." See 52 U.S.C. §20506. Pennsylvania, through its voter registration law, has incorporated these requirements for all elections. See 25 Pa.C.S. § 1325.


In light of these mandates, the Department continues to work with the covered agencies to ensure that the requirements of federal and state law are met. Since 2010, the Department has used bar-coded registration forms that allow the Department to identify the source agency of registrations to more accurately track the Department's efforts, and subsequently ensure that agency efforts comply with the requirements of the NVRA and the Pennsylvania voter registration law.

On December 2, 2017, the Pennsylvania Department of Human Services (DHS) became the first Commonwealth agency to publicly deploy an online voter registration service with the Department. Through this online service, DHS clients submitted more than 13,826 applications in 2020. The Department also worked with the Department of Labor & Industry's (L&I) Office of Vocational Rehabilitation and the Department of Health's Women, Infants and Children (WIC) program to deploy online services. Moving forward, the Department continues to look for other opportunities to modernize voter registration with state agencies.

During the 2020 calendar year, there was a fluctuation in voter registration applications as the COVID-19 pandemic impacted agency services and applicants seeking public benefits. The Department anticipates these numbers to return to more normal levels as agency services return to normal operations.

Pennsylvania Department of Transportation

Since 1995, the Pennsylvania Department of Transportation (PennDOT) has played an integral role in voter registration through what is commonly known as the "Motor Voter" registration process. In 2003, the process became electronic. Motor Voter provides Commonwealth citizens with an opportunity to apply to register to vote while receiving or renewing their driver's license or photo ID at a PennDOT center, as well as the opportunity to update their registration in-person and online. PennDOT voter registration applications can be grouped into two main groups: 1) Initial applications (otherwise known as new applications); 2) Change of Address applications (otherwise known as change applications).

Application Process to Register to Vote at a PennDOT Center

PennDOT customers visit a photo license center with a driver's license application card provided by PennDOT. The application card contains a printed two-dimensional bar code. The bar code is scanned and the computer system determines the customer's age. It then determines which customers will be at least 18 years old by the date of the next election and asks if the customer wishes to apply to register to vote;

The program is designed to ask customers if they are currently registered to vote. If not, they are provided the opportunity to apply to register:

• If a customer is not an eligible U.S. citizen, they do not see the Motor Voter application;

- Customers must confirm that they are U.S. citizens and qualified to register in the Commonwealth;
- Customers who choose to apply to register to vote are asked to confirm their county of residence and indicate a party preference. The customer is asked for optional information (telephone number and race);
- Customers are advised of the penalty for furnishing false information and are asked to sign a
 declaration that the information they have provided is true and correct to the best of their
 knowledge;
- Customers are provided a receipt indicating pertinent information about their voter registration application, including the date on which they applied at the photo license center. The receipt instructs customers to contact their county voter registration office if they do not receive a voter identification card within two weeks.

The completed applications are transmitted electronically by PennDOT's contracted vendor to the Department which, in turn, forwards the applications to individual county voter registration offices via the SURE system. For more detail on how these applications were processed by county officials, please refer to Appendices D and E.

Online Voter Registration


The Pennsylvania Online Voter Registration (OVR) Application was deployed on August 27, 2015. The OVR application provides residents of Pennsylvania with the opportunity to register to vote or change an existing voter registration online and electronically submit voter registration data to their county voter registration office for processing. In order to ensure the successful roll out of online voter registration, the Department actively engaged election stakeholders including county election directors, the elections advocacy community, and Pennsylvania citizens. In an effort to ensure that the final product would be universally useable, DOS also engaged the Center for Civic Design to review the text and the logical flow of information. The Center also field tested the application in an urban and a rural community. This highly interactive development process resulted in a better product overall and one that has been embraced by Pennsylvania voters in overwhelming numbers as seen in usage numbers.

During the 2020 calendar year, approximately 1,162,936 voter registration applications were submitted through the OVR application, including 734,554 new applications. During this same period, a total of 195,860 new paper applications were submitted to county voter registration offices. Since inception, OVR, has accounted for more than 2.73 million applications submitted online through the end of 2020.

Additionally, a relatively new feature to the online voter registration application is the ability to request a mail-in ballot while registering to vote. A separate application will be submitted during the registration process to vote by a mail-in ballot if the applicant chooses to submit the request simultaneously. The Department released this feature in 2020 to further streamline election operations and provide voters additional safe, and secure opportunities to vote during the pandemic.


Comparison of Voter Registration Methods




The graph below illustrates a summary breakdown of OVR usage statistics by age group. It provides a general idea of who uses the online service to register to vote or update their voter registration.



Types of Online Voter Registration Submissions






The graph below provides a summary breakdown of Online Voter Registration statistics, by age group, from the Department's Web API interface.



Types of OVR Web API Submissions






The below graphic visualizes a summary breakdown of application statistics, by age group, for voter registration applications submitted in Paper form.

Voter Hall of Fame

The Pennsylvania Voter Hall of Fame program is administered by the Department of State, Bureau of Elections and Notaries. The program was established to promote awareness and to encourage all Pennsylvanians to exercise their right to vote. The Voter Hall of Fame publicly honors Pennsylvanians who have voted in at least 50 consecutive November elections. The inductees serve as ambassadors in their communities – leading by example and encouraging participation in the electoral process.

In 2020, the Department inducted 39 citizens from eleven (11) counties into the *Pennsylvania Voter Hall of Fame*, despite the COVID-19 pandemic. The 39 new members bring total membership to 23,835, with the membership spanning all 67 counties throughout the Commonwealth. As an ongoing recognition, the Department maintains a display on the third floor of the North Office Building in Harrisburg.

Statewide Uniform Registry of Electors (SURE)

SURE is the Department's centralized voter registration and election management system, which ensures the accuracy and integrity of the Commonwealth's voter registration records maintained by the election authorities in Pennsylvania's 67 counties. The SURE system is a platform that supports the critical functions of the Commonwealth's elections — from determining voter eligibility to maintaining precinct data to producing poll books. A centralized, uniform registry that is accessible to all county offices greatly enhances the overall accuracy and integrity of the voter registration rolls and the resulting quality of voter services.

SURE Voter Registration (SURE VR)

The SURE VR application is used by counties to process and maintain voter registration records and to perform a number of election-related tasks, including the management of vote history, absentee ballots, poll books, election-related reports, and voter registration correspondence to voters.

SURE Portals

Public Portal

Voters can access the SURE Public Portal through the Department of State website, where they can register to vote online, check their voter registration status, locate their polling place, and retrieve electronic balloting materials for Uniform Military & Overseas Voters Act (UMOVA) qualified voters.

County Portal

The SURE County Portal provides counties with voter search, provisional ballot processing/certification, and other basic capabilities through a standard web browser rather than the specialized equipment required to access SURE VR. Counties can use the portal for seasonal and temporary staff who may need to access basic SURE functionality during an election or other busy period of time. Additionally, counties use the portal to upload election results, certify election results, and certify voter registration statistics.

Agency Portal

The agency portal is used by Department of State personnel to maintain elections and campaign finance data. The Department uses the portal to maintain and retrieve the archive of historic election results by precinct and county, manage nomination petitions, and manage campaign finance records.

Kiosk

The kiosk is a public portal which is accessed through terminals located in county election offices and at the Department of State. These portals allow the public to electronically submit voter registration applications, submit changes to their current registration, and search public state-wide voter registration rolls.

Web Application Programming Interface (Web API)

A Web Application Programming Interface (Web API) was created for individuals and organizations that wish to develop a website to gather voter registration application data during voter registration drives. The Web API application contains information these organizations need in order to submit voter registration applications in an electronic format versus submitting paper applications. Entities that are granted access to use the API do not have direct access to the SURE system.

This tool also interacts with PennDOT to capture signatures from valid driver's licenses and sends the Pending Missing Signature correspondence, as necessary. A rigorous certification process managed by the Department of State ensures the individuals or organizations wishing to use the Web API tool meet DOS-identified testing and security standards prior to approving their Web API account. Like online voter registration, signatures may be uploaded through the Web API interface or a request to receive a mail-in ballot may be submitted as a separate application in addition to the voter registration application.
